2. Appointment of a 4th FCB member

After not having any nominations put forward for our 2nd FCB by-elections we are able to move to an appointment system. We have 3 interested candidates who have provided CV/Profiles for the 3 existing FCB members, and 2 FCB Council representatives to go through and then "score" using a process recommended by officers. Our decision will then be given at our next Board meeting before being notified publicly and then confirmed within 30 days.

3. Welcome to Featherston signs - SH2

Since our last meeting the "Welcome to Featherston" signs have been removed. Rhonda Jones and I have had communication with Euan from SWDC about how the signs can be relocated. Unfortunately due to Covid 19 lockdown there has been little progress made although options have been given which will be worked through by all parties to hopefully reach an agreed decision.

4. FCB submission on the proposed SWDC Annual Plan

The FCB held a workshop on Friday, 15 May, to develop its submission on the Proposed Annual Plan. The submission is attached in Appendix 1.
