Mr Wilson advised Council that consultation with the community should be undertaken, with a preferred solution formulated from all the known information against an option of 'is anyone aware of other information that Council should be considering'. Funding options were tabled; Ms Mitchell recommended option two which would result in a minimal rating impact. Mr Allingham, Mr Stephenson and Mr McSherry answered members questions.

- Members noted that the financial impact would extend to all urban ratepayers.
- Members expressed concern that building a manganese plant had increased from \$570,000 to \$2,052,722.
- Members noted the low probability of finding a new Martinborough bore that did not contain manganese.
- Members noted that implementation of a timely solution was paramount in order to mitigate the risk of the ability to provide water during low water reserve periods and to prevent negative economic or reputation impact.
- Members noted that there was capacity to loan fund the required amount.
- Members noted there were contingencies built into the \$2m figure, but that it would be a few weeks before the final solution and associated figure could be confirmed.

- Councillors not able to attend the meeting should be sent a copy of the • resolution and given the opportunity to be briefed before the Council meeting on the 26 June 2019.
- Members noted that Council officer's recommendations needed to be • reformulated to capture the key issues.

ASSETS AND SERVICES RESOLVED (AS2019/15PE):

1. To receive the Chlorination of Martinborough Water Supply Report and the tabled financial update.

- 2. To recommend to Council to engage with the district on proceeding with a manganese plant to allow permanent chlorination based on 75% loan funding with the remainder of the required funding coming from the Martinborough infrastructure reserve.
- To recommend to Council to continue to temporarily chlorinate the 3. Martinborough water supply in the meantime.
- 4. To recommend to Council to continue to design a manganese removal plant, and that purchase of long lead time items should be approved and then undertaken as soon as possible.
- To recommend to Council that Council officers be instructed to take all 5. measures to reduce demand and publicise water use regularly.
- That these recommendations are received in the Council open meeting, but that 6. the report and minutes remain public excluded until community engagement has been completed, and the project has been completed. (Moved Cr Wright/Seconded Hay)
