Tena koutou, tena koutou, tena koutou katoa,

This is a submission to Council on behalf of the Card Reserve Artificial Surface Trust.

The trust has been in existence since 1997 with the opening of the new turf in September 2000 and the turf and its surrounding fencing has been maintained by the trustees. The trustees have also continued to administer the turf with the users and have a developing fund to provide for the re surfacing as when required. We interact with other Card Reserve Users and have a positive relationship within the Card Reserve fraternity.

We are also fully supportive of the initiative of following the Greytown model of “Sportsville”, so that we can all manage the asset of Card Reserve and support the community who play sport in South Wairarapa.

We support wholeheartedly the submission already given by the user groups for the Long Term Plan who have now meet twice with the most recent being March 30<sup>th</sup> 2016 at the Kiwi Hall, Featherston. As a result of the former submission some gains have occurred. The trimming (not removal) of the old trees on Underhill Road beside the Turf was a good start. However as the earlier submission highlighted there is more work to be done as follows:

- Proper maintenance of the grass sports fields including rolling, spraying and re-sowing.
- The development of areas for car parking
- Further tree trimming along Underhill Road
- External access at the Stadium for toileting

I am unsure of the cost for these activities but as you are still to conclude the Card Reserve Park Plans this should be the absolute bottom line in our plan. I note in the 2016/17 operational projects the only projects for Featherston is to fence the children’s playground and improve a driveway at Otairua Reserve adding this as the third project in line with list you have provided would be appropriate.

In conclusion the Card Reserve is a real asset and an obvious “Hub”, for sports for South Wairarapa.

Council should consider a serious look at making this ground the leading facility in South Wairarapa and concentrate its efforts in making this the go to for sports. An upgrade of the swimming baths and all the grass surfaces would be of benefit to the entire Wairarapa sporting community.

This would cement the links of Masterton facilities and Carterton hockey stadium and South Wairarapa covering the entire sporting community on the main State Highway route.

Tena koutou katoa,

Thank you for the opportunity to submit on the new formatted Annual Plan for 2106.

My submission will focus on the key initiatives you have addressed in your flyer to me as a ratepayer of SWDC. I intend to follow the format you have taken.

Therefore key initiatives with options:

- Waste-water - Whilst I believe I understand the need to act quickly for Greytown and Martinborough, the original plan as outlined in the 10 year strategy should be adhered too, therefore I think Option 1 is still a prudent option.
- Pensioner Housing – This is more thoughtful question and I would like to see a detailed Business Plan for each option, I also raise the question of considering further options such as establishing a CCO similar to Hutt City Council for managing the housing stock. Fundamentally consultation should occur around whether Council should consider the Social matters as part of its business or not. I am unaware of that discourse to have a clear policy on this matter. Therefore I support in this instance Option 1.
- Water Supply Assets – Again I support Option 1. There again is little information on the amount that is projected to be underspent. Secondly as previous budgets have indicated a sum of money that ratepayers have supported so monies should not be directed into other projects. This may set an unhealthy precedent. I suspect the under-spend has been based on a lack of growth in the population but that is a guess as this information has not been supplied.
- Speed limits – I support the submission however the Remutaka to Featherston has no speed indicated by you so again it's a guess you would seek to extend the 70km speed earlier and bring the 50km limit to opposite the old dump site. More clarity is needed. What is needed to some strong policing of the speeds throughout Featherston especially by large truck and trailers. Little work has ever been done to rectify this and more work should be done on this. The pedestrian crossing on State Highway Two for the school has seen children killed by fast vehicles and it has been ignored.
- Cycling Strategy All the areas raised with tick boxes should be part of the plan and the major route I would like to see developed is the Pylon Track this track has untapped tourism potential.
- 2107-2017 Operational projects – I support all the projects outlined but ask that some priorities be given whilst you may submit to NZTA about a 30km speed around the playground surely building a fence not changed in 40 + years I have lived in Featherston and protecting children is a priority and quicker to achieve than changing a speed limit. There is clearly an emphasis on Greytown projects but not one of those concerns the lives of children.

- I have already submitted with my Card Reserve Artificial Turf hat regarding Card Reserve and again personally support that submission.

I appreciate the other information contained in the flyer.

#### DUMP STATIONS

◇ Suggest moving the fence at the Featherston dump station to allow two way vehicle travel.

Some financial assistance should be available from our national office.

◇ Greytown Provide access from West st section to Arbour reserve.

Access for through traffic is essential to allow larger vehicles to use the dump station.

At present the dump station is very substandard and borders on being a health risk.

NZMCA would assist by providing the hardware to upgrade this facility and provide a potable water supply . If it could be moved slightly south, access could be made on both sides.

Note!

With the huge increase in motorhomes these facilities are essential to prevent bottlenecks and delays . This is especially the case when special events are held in the area. Where possible our association is providing extra fresh water taps to enable more than one to refill at the same time.

Our association has been increasing at 10% + per year and with a current individual membership of 64000 it is expected to be 80000 very soon. The increase in overseas tourists is also having an impact in numbers.

#### RUBBISH

◇ Council liase with NZMCA with the view to providing some means to collect rubbish from travelling public. Ie. NZMCA Members and the rental van travellers.

Note!

National office will soon be talking with councils to address this problem.

Suggest that as most councils have their own printed rubbish bags a combined nzmca/council rubbish receptacle /bag, with a central collection point ie dump station may be possible.

#### MOTORHOME FRIENDLY TOWN SCHEME

- ◇ Encourage Martinborough to become Motorhome friendly town

If the dump station was to be upgraded Greytown would comply with the requirements to become MHF as well.

Note!

The value of the MHF scheme is now being observed by the participating towns with the free NZMCA website available to promote upcoming events and attractions now being well used. The Wairarapa is reasonably well represented with MHF towns, and the inclusion of Martinborough and Greytown would complete the picture of Wairarapa leading the way.

#### STATE HIGHWAY # 2 speed restriction

- ◇ We agree with the move to reduce the speed limit south of Greytown to 70km per hr.

This would make the access and exit from the Arbour reserve and Kuranui College much safer.

#### FREEDOM CAMPING

- ◇ We recommend that the council take a more aggressive approach to camping by non certified self contained vehicles.

Note!

NZMCA has raised the standard for self containment to a stage above the NZ standards and actively promotes this to all members insisting that members' vehicles be CSC within 3 months of joining the association.

We congratulate the council for providing toilet facilities at strategic locations around the coast and encourage this policy to continue. We believe this will help to solve some of the problems with the non selfcontained campers. Some creative signage could help to encourage the toilets' use. ie "don't be like the bears and crap in the woods, use the toilet"

- ◇ We request that the Park Over Property at the Martinborough rugby club be continued.

Note!

NZMCA Travel directory will be reprinted later this year and continuation of this POP will ensure it is included in the new edition. Not being include in last year's edition would have reduced the knowledge that the POP existed.



For over 20 years we have endured dust from road traffic passing our home at 502 Cannock Road. The number of vehicles especially trucks has increased considerably over time as Pukeatua Station at the road end has been continually developed and more intensively farmed. At times we can have truck and trailer units 30 minutes apart for up to 3 weeks burying our home in dust. During these times we cannot open our doors or windows, put out washing, or mow lawns, garden or relax. The dust still builds up inside and chokes our water filters as we collect rain water for home use. In the not to distant future a considerable area of private pine forest will begin to be logged and this is likely to make our home uninhabitable in summer. The accumulative health effects of this dust are reasonably obvious and the continual grinding away at our quality of life is quite depressing. When it was an occasional vehicle that was just part of country life but it has now gone way beyond that. The only real permanent solution is to seal approx 120m of road out side our property which will permanently solve the problem. I know you've spent considerable amounts of money sealing Te-Muna road over the past few years and it is my hope that it may now be possible to seal a small section on Cannock rd for us. I'd be more than happy to discuss solutions at any time and hope we can move forward with returning our quality of life and health into the future. Thank you.



Physical activity has been identified as a preventative treatment against non-communicable diseases such as obesity and diabetes, and cognitive disorders such as depression and anxiety. When children engage in physical activity it enhances not only their physical wellbeing but also their cognitive, social, spiritual, cultural and emotional wellbeing.<sup>ii</sup>

Investing in quality infrastructure that encourages a shift towards increased physical activity has shown to be cost effective and can provide significant co-benefits. Physical activity has been shown to provide economic efficiency by promoting fuel savings, reduced road maintenance cost and increasing workplace productivity, to name a few. All of these positive outcomes can only mean beneficial things for the South Wairarapa District Council.

Acknowledging the large effort that goes into creating a 'Bikes in Schools' programme at one school, the three Featherston Schools have jointly decided to create a community resource that they are all able to access and utilize.

Traditionally, all bikes, tracks and helmets are owned and maintained by the school and remain the school property to be used as part of the school's physical (and wider) education programme. The track is usually built on school grounds. Following discussions with the Featherston Primary Schools, they would like to customise this project so it is most beneficial for all three schools and the wider Featherston community. The three schools jointly see the largest community benefit would occur if the tracks were located at a public location on council land, Card Reserve. As such, this letter supports the idea of including agreement in the Annual Plan to utilise Card Reserve in Featherston to provide and create community good in the form of a 'Bikes in Schools' modelled facility.

This is a valuable opportunity for the South Wairarapa District Council to consider a project that will be community driven. With the schools leading community discussions of how to establish this community asset it will also compliment the South Wairarapa District Council's cycle strategy. The 'Bikes in Schools' model ensures every primary school child has the opportunity to learn how to cycle, thereby promoting equity in the community, and increasing accessibility to participate alongside their wider community on other cycle ways in the future.

Specific details of how this project will be led are still to be confirmed. Fundraising for the bikes, storage shed and helmets could be led by the schools, seeking the support from the local community and local organisations such as the Greater Wellington Regional Council, Regional Public Health and Wairarapa Road Safety Council. Following the recent completion of the 'Bikes in Schools' initiative at Lakeview School, discussions have started regarding establishing a 'Bikes in Schools Wairarapa' charitable trust to ensure that sustainability is promoted and achieved. The success of the 'Bikes in Schools' project at Lakeview School stemmed from the strong support provided both in principal and financially from local organisations, including the Masterton District Council.

Health is a prerequisite to achieving success in all areas of our lives; health begins where we live, learn, work and play.<sup>iii</sup> This ties in closely with the South Wairarapa District Council focusing on community driven projects that promote the success and wellbeing of their community. I recommend that South Wairarapa District Council supports the Featherston educational community to create this community resource at Card Reserve.

Acknowledging the large effort that goes into creating a 'Bikes in Schools' programme at one school, the three Featherston Schools have jointly decided to create a community resource that they are all able to access and utilize.

Traditionally, all bikes, tracks and helmets are owned and maintained by the school and remain the school property to be used as part of the school's physical (and wider) education programme. The track is usually built on school grounds. Following discussions with the Featherston Primary Schools, they would like to customise this project so it is most beneficial for all three schools and the wider Featherston community. The three schools jointly see the largest community benefit would occur if the tracks were located at a public location on council land, Card Reserve. As such, this letter supports the idea of including agreement in the Annual Plan to utilise Card Reserve in Featherston to provide and create community good in the form of a 'Bikes in Schools' modelled facility.


This is a valuable opportunity for the South Wairarapa District Council to consider a project that will be community driven. With the schools leading community discussions of how to establish this community asset it will also compliment the South Wairarapa District Council's cycle strategy. The 'Bikes in Schools' model ensures every primary school child has the opportunity to learn how to cycle, thereby promoting equity in the community, and increasing accessibility to participate alongside their wider community on other cycle ways in the future.

Specific details of how this project will be led are still to be confirmed. Fundraising for the bikes, storage shed and helmets could be led by the schools, seeking the support from the local community and local organisations such as the Greater Wellington Regional Council, Regional Public Health and Wairarapa Road Safety Council. Following the recent completion of the 'Bikes in Schools' initiative at Lakeview School, discussions have started regarding establishing a 'Bikes in Schools Wairarapa' charitable trust to ensure that sustainability is promoted and achieved. The success of the 'Bikes in Schools' project at Lakeview School stemmed from the strong support provided both in principal and financially from local organisations, including the Masterton District Council.

Health is a prerequisite to achieving success in all areas of our lives; health begins where we live, learn, work and play.<sup>iii</sup> This ties in closely with the South Wairarapa District Council focusing on community driven projects that promote the success and wellbeing of their community. I recommend that South Wairarapa District Council supports the Featherston educational community to create this community resource at Card Reserve.

**Submission by the Wairarapa Youth Education Training and Employment Network  
South Wairarapa District Council - Consultation Document 2016/17**

## 1. Introduction

The following is a submission from the Wairarapa Youth Education Training and Employment Network (YETE) to the South Wairarapa District Council (SWDC) regarding the Consultation Document for 2016/17.

## 2. Background

It is widely accepted that there are links between education, access to employment, crime and benefit dependency. Recent analysis of education data has determined that young people who leave school without NCEA and are unable to find employment will need to access the benefit system and are far more likely to spend longer periods on a range of benefits than those who move directly into the workforce.

We also know that the Wairarapa is currently experiencing increased challenges to keep our young people engaged as positive and contributing members of our communities, and there is increasing evidence that this is a real issue for South Wairarapa.

We are seeing:

- growing disengagement by youth evidenced by increased unemployment, alcohol and drug use, offending, anxiety, depression, and other health issues;
- increased and waste-full public spending on further education, health, social welfare, and crime;
- unfulfilled regional economic development; and
- no co-ordinated local mechanism or structure that enables tertiary institutions, industry, employers and schools to collaboratively connect education to employment.

Along with this the Social Sector Trial (SST) identified the need to *“Increase participation in education training and employment”* as a key outcome for the Wairarapa.

Research shows that the Wairarapa is underperforming in some aspects of youth employment transitions and this is supported by another key finding of the SST about the lack of co-ordination and collaboration between schools, industry trainers and employers in creating pathways for young people to transition seamlessly between them.

In an attempt to address this, an inter-sectorial partnership has been formed to develop a “bottom up”, community-led initiative, the Youth Education and Employment (YETE) Network. The intention is to strategically align resources and efforts in the whole of the Wairarapa to support our young people to reach their vocational and/or educational potential by developing appropriate pathways that allow them to transition from school through tertiary education to employment.

The YETE Network comprises of representatives from secondary schools, tertiary educators, employers, community groups (particularly those working with youth), local authorities, iwi and central government agencies such as Ministry of Education, CareersNZ and Ministry for Social Development.

YETE's purpose is to:

- ensure a wide range of locally led community groups/sectors work together in a connected and collaborative manner for the first time;
- improve community, business and educational outcomes by bringing together a range of agencies, Non Government Organisations, educational organisations, local bodies and employers with the common goal of providing relevant, purposeful and coherent pathways from education to employment;
- strengthen and grow the provision and range of career services and information that is localised to the Wairarapa;
- establish and facilitate the free flow of information between employers and job seekers in the Wairarapa;
- collaborate and strengthen education and training pathways for youth "at-risk" of not going into further education, training or employment;
- grow and build employer partnerships with schools and tertiary institutions to promote and establish more relevant learning pathways;
- ensure schools are well informed regarding local employment needs and opportunities;
- ensure employers have a better understanding of "millennials", their characteristics and how best to work with them; and
- strengthen understanding of cross-cultural competencies and how these relate and could benefit the work place.

Outcomes that will be achieved through the YETE initiative include:

- improved economic growth and development;
- improved life outcomes for young people – lives filled with meaning, purpose and achievement;
- a stronger, more productive, more positive and more vibrant community;
- a happier, healthier and more socially integrated community; and
- less time and effort spent on restorative activities.

### **3. Feedback on the SWDC Consultation Document 2016/17**

The Consultation Document (CD) states that the South Wairarapa Community Outcomes are:

- Healthy and economically secure people
- Educated and knowledgeable people
- Vibrant and strong communities
- Sustainable South Wairarapa
- A place that is accessible and easy to get around

The outcomes identified for the YETE initiative supports the achievement of the above Community Outcomes for the South Wairarapa. The initiative provides a structured, co-ordinated and supported vehicle that will focus on developing pathways for all Wairarapa youth to become engaged in meaningful education, training and/or employment resulting in:

- healthy and economically secure people
- educated and knowledgeable people
- which in turn will likely result in "Vibrant and strong communities" and a "Sustainable South Wairarapa".

It is understood that the South Wairarapa CD does not itself provide for any direct investment to support the achievement of the important Community Outcomes stated above.

*This application asks the SWDC to consider making a direct financial investment of \$15,000 to \$40,000 per annum to support the work of the YETE initiative in order to directly benefit youth and local business and therefore the wider community in the South Wairarapa district.*

#### **4. Conclusion**

This submission emphasises the need for a fully co-ordinated and structured approach that strategically aligns resources and efforts across the whole of the Wairarapa to support our young people to reach their vocational and/or educational potential. The benefits of which are considered immeasurable while the cost of not doing so could be catastrophic for the future of our communities.

Representatives from the YETE Network would be available to speak to this submission at the hearings of 25 May.

Steffan Browning MP – Green Party

This submission requests that the South Wairarapa District Council phase out the use of glyphosate and similar based herbicides from its streets, playgrounds and parks.

Glyphosate was listed by the World Health Organisation last year as a probable carcinogen, and glyphosate based herbicides have been shown to have other negative health and environmental effects, raising concern for community and worker health, and possible liability issues. Effective non-toxic alternatives to glyphosate based herbicides are increasingly being used by councils.

Consideration of the negative effects of herbicides in the environment must be a clear part of the council's Long Term Plan, especially at a time when science validating community concerns is increasingly available. The Annual Plan process is an appropriate and quick way of ensuring urgent changes needed for improved community wellbeing.

Tourism – Clean green 100% Pure Aotearoa New Zealand branding is an important component of the success of tourism to your region and New Zealand generally. However roadside, playground and park spraying is contrary to that image, with many tourists surprised to see what appears to be a cavalier attitude to agricultural use here, especially in urban areas. Many countries have already severely restricted use of glyphosate based herbicides in urban areas, with some banning all uses. In fact, this April, the European Parliament called for a ban on all uses of glyphosate-based herbicides in private and public green areas, including spraying in and around public parks, playgrounds and gardens.

Christchurch City Council also recently voted to stop the use of glyphosate based herbicides in all areas open to the public. While that doesn't go as far as many overseas jurisdictions, or ensure full community safety from the herbicide, it is an appropriate move for a local authority to take when a threat to community, worker, and environmental health is recognised.

Continued use of glyphosate and similar based herbicides in your region, especially in urban areas, is a potential risk for the community, workers and for the tourism brand.

Significant scientific evidence has shown that:

1. Glyphosate affects bacteria's response to antibiotics
2. Glyphosate damages hormones and is a probable carcinogen
3. Glyphosate is often combined in weed killers with other active ingredients that are more toxic to animals and people than glyphosate by itself
4. When it enters waterways, glyphosate harms fish and other aquatic animals
5. Glyphosate negatively affects the natural behaviour of bees, causing them to forget where their hives are
6. Glyphosate leaches into groundwater
7. We don't know what a safe level of glyphosate is, as it has never been assessed by regulators at sub-lethal levels.
