Monday to Thursday 10.30am to 10.30pm (extended to 11.00pm during daylight saving) Friday to Sunday and Public Holidays 10.30am to 12.00 midnight

- 5. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
- 6. The club must have at least one properly appointed certified manager.
- 7. The Licensee must have available for consumption on the premises, at all times when the club is open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 8. Drinking water is to be provided to members and their guests free of charge from a water supply prominently situated on the premises.
- At all times when the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available. Menus must be visible and food should be actively promoted.
- 10. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licenced premises.
- 11. Alcohol can be sold and supplied to guests of members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members.
- 12. The Licensee must display:
 - At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises.

THE LICENSED PREMISES

The premises, situated at Soldier Settlement Road North, Featherston, are more precisely identified as outlined in a plan date stamped as received by the Masterton District Licensing Agency on 27th July 2015.
