Dear Adrienne

Thank you for forwarding me a copy of your letter dated 13 June 2013. Regrettably we did not receive the original, and I sincerely apologise for the lack of response until now – it was in no way intentional.

Under the Government's Rural Broadband Initiative (RBI), we are actively improving connectivity for rural New Zealanders. We are over halfway through the RBI programme, and ahead of the RBI targets, completing the construction of 77 new sites, and upgrades to 251, meaning new services for over 170,000 addresses around New Zealand – delivering not only broadband access, but significantly expanding mobile voice, TXT and data coverage.

In the Wairarapa, we have already upgraded four of our six towers (Carterton, South Wairarapa and two in Masterton) and built two of the five new towers planned for the area – at Riversdale Beach and Castlepoint. New sites at Opaki, Carterton Central and Palliser Bay are planned for the next two years of the RBI programme.

Greytown is currently serviced by the Featherston tower. Featherston is scheduled to be upgraded as part of the RBI, which will improve capacity and extend wireless broadband services to an extra 1200 rural addresses. Unfortunately, at this point there are no plans to build a new cell site in Greytown.

At the conclusion of the RBI programme, Vodafone will review any potential gaps in its coverage footprint. Our current focus is delivering our contractual commitments for the RBI programme.

I have asked our Community Relations Manager, Caitlin Metz, to call you to discuss any further concerns you or the council may have.

Trees Around GreytownMemorial Park, -

1st World War 100th Anniverary

One of the important heritage features of Greytown are the trees surrounding the Memorial Park honouring the 112 men from the Greytown area who were killed during World War 1. The area around the avenue of 55 Lime Trees facing Kuratawhiti Street is well maintained and to a lesser extent so is the area surrounding the Plane trees on the Scout Hall side of the park. In recent years the avenue of Beech and Elm trees on the North side of the park have become very untidy with overgrown grass and tree seedlings.

As we will this year be commemorating the 100th anniversary of the commencement of the First World War we would suggest that it would be a good time to clear out the area around the avenue of trees on the North side and

plant grass seed to incorporate this in the mowed grass area of the park.

We have counted in excess of 150 trees surrounding the park so there are more than the 112 for the men who will be given special honour on ANZAC DAY 2014. If the Council agrees to have this work done it would be desirable for it to be completed in early April prior to Anzac Day this year.

We see in the Heritage Tree Trail pamphlet (copy attached) that the Tree Trail leads visitors to walk through the avenue of Beech and Elm trees on the North side of the park. Because this area has been allowed to become overgrown and very untidy people are now unable to do this.

If the Council agrees with what we are proposing would they arrange for the work to be carried out by City Care?

We would also like to draw the attention of Council to a number of old tree stumps near the boundary on the park facing the Scout Hall. These should be removed with a stump grinder and no doubt City Care would be able to attend to this.


