ILLEGAL RUBBISH DUMPING

Purpose of report

To inform councillors how Council deals with the illegal dumping of rubbish and issues encountered in the Bucks Road area including a private property.

Recommendations

Officers recommend that the Council:

1. Receive the information.

1. Executive summary

Council has and does deal with the illegal dumping of rubbish on its land reserves however does not extend this to private property. As showing in appendix one there has been issues including couches, TV's and beds. These areas are cleared and removed as soon as possible to ensure the amenity of the area is preserved where possible.

Council has erected signage to deter this from happening on its own land and other areas. Also council has supported the TV Take Back program as well as e-recycling.

2. Background

Council has received requests to stop the rubbish being dumped at Bucks Road as well as the need to develop a policy to deal with the dumping on private land. Signs that were erected have not resolved the issue.

The request to "to establish the river bank as a rubbish free zone" is common sense, and covered under the litter act 1979'

Deposit of litter in public place or on private land

- (1)Every person commits an offence and is liable on conviction, in the case of an individual, to a fine not exceeding \$5,000 or, in the case of a body corporate, to a fine not exceeding \$20,000, who deposits any litter or, having deposited any litter, leaves it—
 - (a)in or on a public place; or
 - (b)in or on private land without the consent of its occupier.

- (a)in or on a public place; or
- (b)in or on private land without the consent of its occupier.

The river reserve is also under the management of GWRC.

The territorial authority may require the occupier of the land to clear litter. Any territorial authority may serve or cause a Litter Control Officer appointed by it to serve, on its behalf, on the occupier of any private land or any land vested in or controlled by the Crown or any local authority (within the meaning of <u>section 5(1)</u> of the Local Government Act 2002) a notice in writing requiring the occupier, to the satisfaction of an Officer,—

- (a)to clear away, or remove, from the land; or
- (b)to clean up; or
- (c)to screen, cover, or otherwise obscure from view—

such litter as may be specified in the notice within 14 days or such further time as may be so specified, being litter which, in the opinion of the territorial authority, tends to grossly deface or to defile the area in which the private land is sited

3. Discussion

Council organised for the sign originally and subsequently the second time around. Tim Langley, Roading Manager, has been to see if there was a practical way of erecting a barrier on the road to prevent dumping (generally dumping is from just two spots). It was considered that a barrier within the road reserve would not work so this idea was abandoned, hence the sign.

Staff had been to the site previously and gone through the waste to try and identify any of the rubbish to any person responsible. The car bodies dumped were identified and on enquiry the Police advised they had been stolen.

Regardless, even if some papers with names has been found this cannot be used in Court as there is no proof of connection between that person (name on paper or whatever) and the dumping of the waste.

In reality the dumping is onto private land. The landowner has the ability to erect a fence along that property boundary which would limit or completely exclude the dumping activity. Council does not erect fences on any other property frontages; this is clearly a landowner responsibility.

The prior correspondence raises service delivery issues in waste management that is a district wide issue such as transfer station times and costs. These issues are continually addressed through the LTP and annual planning phases of council. It's the officer's opinion that even the reduction in costs or more opening hours for the transfer stations will not deter "fly tipping" as this is often a convenience issue or one of legality.

Council could require the land owner to clear the rubbish but has not taken this course of action as it is seen as difficult for the land owner to control.

3.1 Options

Council could at their cost take on the cleaning of private land issues which would be at the expense of the general ratepayer, as would be an extension of hours.

Council could enforce the landowner to clear the rubbish but has not felt that this is justified.

3.2 Consultation

Fees and charges as well as service delivery is covered annually in consultation.

3.3 Legal

The cars that have been reported to the police have been identified as stolen. This is a matter for the police on follow up on.

The prosecution is possible where the offenders are caught or the land owner is requested to clear it.
