It is important for Council to facilitate an environment to support economic growth, make Wairarapa as attractive as possible by providing good infrastructure and facilities so that businesses and entrepreneurs want to bring their business to the region.

Key issues from meeting	 Overview of Public Transport – Paul Swain Transdev have partnered with Hyundai Rotem to deliver the new public transport contract for the Wellington Region which is due to start on 3 July 2016. Kiwi Rail owns the tracks, platforms, signals and electric overhead wires. GWRC owns the rolling stock, station buildings, car parks and cctvs. It leases the locomotives that pull the Wairarapa trains. As part of the changeover of contracts, fare structures will be reviewed and streamlined. This will also assist the move to electronic ticketing scheduled for 2018. Bikes on trains – mainly a weekend problem. Proposed to run the spare generator van which should give enough luggage capacity to accommodate cycles as well as luggage.







Re Three week Wairarapa Smokefree Outdoor dining promotion

Compass Health and the Wairarapa Smokefree Network¹ invites the Wairarapa Hospitality industry to work together to provide smokefree outdoor dining for a "3 week trial period" – **31st May to 21st June.**

Background:

Many Australian restaurants and cafes are currently enjoying increased patronage and revenue. How? Because they have smokefree outdoor dining, and place smokefree signage on outdoor tables. Sounds odd, but if you think about it, most people don't smoke and most smokers want to quit, so diners could potentially be avoiding smoky tables and may not even want to walk past them and into a dining establishment.

What do you need to do?

Simply discard ash trays and pop up some signage at your establishment. Some people may still choose to smoke, but most won't. Worth a go we think.

What you don't need to do:

We don't expect you to 'police' smokers or 'tell people off', just put the signs up and see what happens. It may be some time before NZ follows Australia's lead and legislates for smokefree outdoor dining, but why wait? Let's go after increased local revenue, look after the health of our staff and diners by protecting them from second hand smoke and help smokers quit and stay quit by increasing smokefree environments.

What will we do for you?

We provide smokefree signage to you free of charge, we will also advertise all businesses keen to join in our 3 week smokefree outdoor dining promotion through local radio and newspaper channels and have prizes on offer for your customers.

Who is Compass Health, and why are we interested in supporting a promotion like this?

Compass Health Limited is a primary health organisation. Our role is to support the health of the Wairarapa community, advocating for improved health services and healthier environments, and to support Medical practices to provide healthcare services.

One of our health focusses is to support people to become smokefree. This includes the provision of stop smoking services and advocating for increased smokefree environments. The majority of smokers want to stop smoking, and by providing smokefree areas it helps them to remain smokefree. We are keen for the Wairarapa Hospitality industry to join with us to provide increased smokefree areas, by providing smokefree outdoor dining for a "3 week test period", to see how you find it.

¹ The Wairarapa Smokefree Network is a collective who support Smokefree Aotearoa 2025, smokefree services and smokefree environments. Partner agencies are; Compass Health Limited, Cancer Society, Heart Foundation, Regional Public Health and Whaiora.

Compass Health invites your business to participate in a smokefree dining promotion running for three weeks – 31st May to 21st June. We have selected this timing as World Smokefree Day is on May 31st, which makes it an ideal 'kick off' day.

We are really impressed to see many restaurants and Cafes in the Wairarapa have already made their outdoor tables smokefree by not providing ash trays and simply advising customers they support smokefree dining when they request an ash tray. Some have even made their own signage to display.

The detail

You may not have considered smokefree outdoor dining. This is an opportunity for your business to experience how your customers feel about it. In Australia smokefree outdoor dining is proving successful, resulting in increased sales. A fact sheet of questions and answers from Otago University is enclosed for your interest.

Should you be interested in joining our promotion Compass Health will fund and provide the following;

- 1. Advertising on Radio and in Wairarapa Newspapers with a list of all participating dining establishments who are supporting smokefree outdoor dining for 3 weeks, along with an outline of the competition people can enter to win one of five x \$50 dining vouchers
- 2. We will provide smokefree signage to display
- 3. We will provide an entry box for diners to fill out a yes/no survey on "I support" or "I do not support" smokefree outdoor dining. All entries will be eligible to win one of five \$50 dining vouchers. The survey will state which dining establishment they completed the survey at, and the voucher will be allocated to that establishment. (Compass Health will pay for the \$50 vouchers and the winners will be drawn at the end of the 3 week promotion)

This promotion will enable Compass Health to;

- 1 Discover how smokefree dining affects your business from your feedback
- 2. Gather data via the survey on public opinion on smokefree outdoor dining
- 3. Discuss providing ongoing support for you should that be feasible.
