These are intended to help build understanding of past decisions made on the Waihinga Centre proposal, and of next steps foreseen by Council and the Community Centre Steering Group.

At this stage, I request that this letter and the attached questions please be tabled at Council's monthly meeting on 18 November. I also request an opportunity for myself or another member of our ratepayers group to briefly address that meeting at a suitable point on the agenda.

As stated publicly on various occasions, our purpose is simply to help Council inform the Martinborough community more fully on all aspects of the Waihinga Centre proposal, and to promote community engagement in decision making on this project by Council and the Steering Group from this point onwards.

I look forward to hearing from you in coming days about the requested meeting. I also look forward to attending Council's regular meeting on 18 November.

# **Questions to SWDC Mayor and Councillors**

#### **Next Steps**

- 1. Following Council's resolutions of 26 August and 4 November, does Council and the Community Centre Steering Group intend that the Waihinga Centre proposal will proceed in a "new form" and if so, how and when will the community be engaged in decision making on this new form? (The resolutions above bind Council not to proceed with the "current form".)
- 2. How and when will Council follow sections 3 and 5 of its Consultation Policy to ensure that it has determined "the overall community view" on any new form of community centre project?
- 3. Given that Council consulted the community on its targeted rate proposal and resolved not to proceed with that proposal, is Council able now to confirm its previously-stated position that no town hall or community centre project will have additional effect on rates in the South Wairarapa District?

#### **Community Centre Steering Group**

- 4. Why has Council delegated so much decision making to the Community Centre Steering Group on this project? What are the Steering Group's terms of reference (as approved by the Council in October 2014 but not published on the SWDC website)?
- 5. How was membership of the Steering Group decided? What effort was made during 2014 or since to ensure that the group included a cross section of the Martinborough community (or in fact, was this not a Council intention)?
- 6. Can Council give absolute re-assurance that it retains proper oversight and accountability for the project as the community expects given the cost and significance of the project?
- 7. Why did the Steering Group on Council's behalf set about securing financial pledges from certain individuals and groups in the Martinborough community and not others? Why did Council not follow the same approach adopted when community support was solicited for the Martinborough Medical Centre, ie people were able to contribute labour, time, expertise and other resources as well, or instead of, money?

#### **Community Engagement & Decision Making**

- 8. How and why did the Council decide that the community centre project should move from a "consultation phase" into a "design phase" (as Council minutes indicate has been the case since 15 October 2014)?
- 9. Following the public presentation of a community centre design concept (including visual designs) in April 2014, what community submissions did the Council receive? How have those submissions or any other form of community input been considered in decision-making by Council and the Steering Group between May 2014 and November 2015?
- 10.In March 2012, Council held a community hearing to gather information and opinions on options for the Town Hall, including strengthening the current building or demolition with either replacement or non-replacement. Only six people submitted in favour of retaining and strengthening the existing building. On what basis, and when, did Council decide to pursue that option (and drop the others) *and* to convert a strengthened town hall into a community centre?
- 11.Can Council demonstrate how, in 2012 and since, it has met its obligations under sections 77, 78 and 79 of the Local Government Act 2002? (These sections place obligations on Council to assess options for the Town Hall in terms of their advantages and disadvantages, to engage the community in Council decision making and to quantify costs & benefits.)
