# PLANNING AND ENVIRONMENT GROUP REPORT

#### **Purpose of Report**

To update Councillors on the Planning and Environment Group's activities.

### 1. Planning

#### 1.1 Resource Consents

Council processed 15 resource consent applications from 15 July 2013 to 4 September 2013. 94% were processed within statutory timeframes (please refer to detailed fortnightly updates for more information).

#### 1.1.1. Featherston Supermarket Site

Trust House has submitted a resource consent application for a new supermarket building in Featherston. This application has discretionary status under the District Plan. After an initial assessment was completed it was determined that the application does not require full public notification. There are however, several parties who are deemed to be potentially affected by the application. If the applicant can obtain written approval from those parties for the proposed development, the consent can be processed under officer delegation. If the applicant does not obtain those written approvals, the application will proceed under the limited notification provisions of the Act.

#### 1.1.2. Policy / Plan Changes

Decisions on Plan Changes 6, 7, and 8 were released on 5 June 2013. No appeals were received; therefore under section 86F of the RMA 1991 the Plan Changes are operative.

#### 3.1 Liquor Licensing

#### 3.1.4. District Licensing Committee

Interviews for prospective list members of the District Licensing Committee have been scheduled for 13 September 2013, with each Council having a representative on the interview panel.

#### 3.1.5. Local Alcohol Policy

A draft timeline for the joint LAP has been completed. The forward programme of work is;

- 1) Preliminary Research this is planned to be completed by December 2013;
- Preliminary community consultation commence Feb/March 2014;
- Develop Draft by end of June 2014;
- 4) Full consultation on the Draft Policy complete in July/August 2014,
- 5) Develop Provisional Local Alcohol Policy, notify, process appeals and finalise by the end of September 2014;
- 6) Adopt Policy.

#### 3.4.4. Dog Exercise areas

A meeting has been held between Council's Property Officer and the Greytown Lions President, about the development of a Greytown Dog Exercise Area. It is proposed that the works will be project-managed by City Care, who will also do the materials purchasing. Lions have agreed to contribute labour for the fencing work. The intention is to have the park up and running by the end of this year. Some Lions members are keen to contribute further with the supply of equipment (for obedience and agility training).

#### 3.5 Bylaws

Council Officers received seven bylaws complaints from 18 July 2013 to 1 September 2013. These consisted of one litter complaint, five tree obstruction/long grass complaints and one abandoned vehicle complaint.
