2. Featherston Sculpture - "Sod Turning" ceremony

It was a great privilege and pleasure to host Her Excellency the Governor General Dame Patsy Reddy at the turning of the first sod for the foundations of the Featherston Camp Sculpture on 24th August. The weather was not conducive to hold the whole ceremony being held outside but the Fell Museum opened their facility that enabled the speeches and the delicious morning tea to be held in the warm and dry.

The ceremony was attended by people who have been an integral part of the project to date; The Featherston Camp Sculpture Trust trustees, Paul and Faye Dibble, Featherston Heritage Museum, Featherston RSA, SWDC Councillors, Featherston Community Board, ANZAC Club, funders, contractors and supporters. MP's Alistair Scott and Keiran McAnualty also attended.

3. Whaitua

The Ruramahanga Whaitua Implementation Programme has been accepted by GWRC. I attended the launch of the document at Te Ore Ore Marae. This was a special event for the Whaitua Committee. I want to once again acknowledge the work that Cr Colin Olds has done representing SWDC on this committee. It is very much appreciated.

4. Chor Farmer

The Japanese Chor Farmer Men's Choir visited Featherston from 4^{th} to 6^{th} September. Their concert was on 4^{th} September and there was a full house. On 6^{th} September the group laid wreaths and sang to commemorate the Featherston Incident. Mr Hiroshi Masumoto the musical director of the choir and I unveiled a sign explaining the history of the garden and recognition of their financial support for the garden by Chor Farmer over the last 18 years.

Chor Farmer also travel to and perform in Cowra as part of their Goodwill Tour.

5. Community Board Working Party

In the run up to the amalgamation a small working group was formed to give the Local Government Commission SWDC recommendations for the best model for community boards in an amalgamated council. The ideas and suggestions from this group formed the basis of the council submission to the Local Government Commission.

With no amalgamation happening I believe that SWDC needs to review the Terms of Reference and delegations to the Community Boards. This was backed up by comments in the Governance Review, I therefore recommend that the Community Board working group is formalised into the Community Board Working Party and Terms of Reference are adopted. Membership would be the Mayor, a councillor form each ward and the chairs of the Community Boards.

Positive Aging Strategy

The Office of Seniors has granted funds to enable SWDC, CDC and MDC to work together to develop a Positive Ageing Strategy for the Wairarapa. An officers group has been meeting and are conducting council and community surveys. Jennie Mitchell has been the SWDC representative on the group.

Submission from South Wairarapa District Council (SWDC) to ANZ Bank regarding the closure of the ANZ Martinborough Branch

Dear Andrew,

I have been instructed by South Wairarapa District Council to write to you to express our deep disappointment and concern regarding the ANZ proposal to close the Martinborough Branch in a few weeks.

Council is extremely concerned that ANZ has taken a very narrow focus in reaching its decision to the proposal. Martinborough and the South Wairarapa District are one of the fastest growing areas in the country. The growth is in all areas; population, tourism, economic and the number building and resource consents issued in the last two years. ANZ seems to have unfortunately ignored these factors when making its decision and based the proposal only on the numbers of people entering the branch in the last year which according to the information you provided Cr Pip Maynard and me is a drop of 6%. We would have expected that ANZ would have looked at the future requirements and opportunities to grow its customer base rather than past statistics.

The Martinborough community is to say the least very upset with this proposal. As you are very aware there have been concerns raised by the community regarding access businesses and people without computers or smart phones have in accessing their banking needs. Martinborough has a high elderly population, 22% are over the age of 65. We have been told that many of your older customers still use a checking account for their banking. Many of these people have limited mobility and/or do not have relatives locally to take them to Masterton and will therefore be seriously disadvantaged and alienate by the branch closure.

We understand that many people do use internet services for banking but the ones that do not, for whatever reason, should not be penalised because they live outside a larger town. Travel to the nearest ANZ will now be an 80km, $1\frac{1}{2}$ hour round trip to Masterton or a 100km, 2 hour return trip to Upper Hutt. I have heard from many businesses and private individuals that changed their bank to ANZ from BNZ when that branch closed just 15 months ago. These people are extremely angry and these are many of the people who will be most disadvantaged if the branch is closed.

SWDC request you reconsider this proposal and retain the ANZ Branch in Martinborough.

Early research has told us that:

- Fewer older adults will own their own homes in future.
- In the Wairarapa, early results from our District Council staff and politicians survey tells us that transport, services to older adults and opportunities for social connection are important issues.
