General	 WCC is going to do a food waste trial in the 2019/20 year Since China stopped accepting plastic recyclables there are lots of conversations around the plastic problem New Zealanders urgently need to be educated to distinguish between recycling/diversion/waste minimisation Recycling doesn't really happen until recycled product is bought and reused. 	

Following the meeting Cr Colenso and I enjoyed a factory tour of Flight Plastics. They buy back used NZ-made clear PET (bottles, packaging) to mix with new product and remanufacture into clear food packaging, which can be recycled over and over again. Currently the clear meat trays used by NZ supermarkets are manufactured using imported resin which cannot be re-mixed with the NZ manufactured PET for recycling as it is a different grade of RPET. If the NZ supermarket chains are made aware of this and request the manufacturers of their clear meat trays to use NZ manufactured PET the clear meat trays will then be recyclable for re-use and re-manufacturing.

Local Government New Zealand Conference

Christchurch 15th to 17th July 2018

I would like to take this opportunity to thank my fellow Councillors and her Worship Mayor Napier for supporting my wish to attend Conference this year.

Along with Councillor Jepson we planned to arrive in Christchurch around 10am on Friday the 13th with the intention of travelling to Tekapo to gain a little more knowledge, from this district, on creating a Dark Sky Reserve. This followed an invitation from Mayor Graham Smith of the MacKenzie district council to visit and look at what his district had achieved. For me, I was keen to listen to the presenters, who are the experts in their field, to understand the complexities of local Government and how this

information can be applied to our own environment.

Topics covered included:

Building a Strong Community – a tale of a new region.

Building strong local prosperity.

Inspiring Maori connections to grow thriving, prosperous communties.

Working together to tackle three waters infrastructure challenges facing New Zealand.

As you may be aware the Ruamahanga Whaitua committee presented it's final Implementation programme to Greater Wellington Regional Council meeting on Thursday the 16th of August.

The document was received by GWRC for the next stage in it's journey, to be endorsed by Te Upoko Taiao before, and after a plan change, becoming a chapter in the Natural resources Plan.

This project commenced back in November 2013 when I was appointed by Mayor Adrienne Staples to represent our district on this committee. The time frame was estimated to take around two years to complete. After 4.5 years and countless hours of reading, workshops, community and committee meetings, I can safely say that we have completed our task.

Over this period I have attempted to keep Council informed, more about where we are in the process rather than the technical aspects of our work. This has been a complex exercise having wide ranging effects on our district in the coming years.
