Key issues from meeting	There are currently changes proposed to the LG Act which will have huge ramifications for councils and their communities. LGNZ has circulated its concerns to members and on behalf of us all submitted to parliament against the proposed changes. Some councils also lodged individual decisions. SWDC opted to support LGNZ (as did many councils) and we supported in person, President Yule when he appeared before the select committee. It is too early to tell what the outcome will be but early indications are that the government is prepared to consider changes to the bill as it stands.
