#### **Purpose of Report**

#### SWDC will provide to Featherston Menz Shed Inc. the following:

- The free building, once the Bottle Shop, donated to Council by Trust House;
- A site to relocate the building such that the front portion is located on the vacant Main St land adjacent to the skate park and facing the Main St, and the rear portion of the building is located on the Fox St land behind this as shown in the recent Council proposal;
- The consents required for the relocation of the building;
- The connection of sewerage and water services from the building to the Main St;
- Annual Insurance for the building;
- Permission for unencumbered vehicle access (a driveway) from Fox St to double doors at the rear of the building;
- Agreement on permission for limited expansion of the Shed at the rear or side as required.

#### The Featherston Menz Shed has the following responsibilities:

- To bear the cost of and assist as required with the relocation of the building including the actual removal and the creation of a new foundation on the land provided by the Council together with the creation of driveway access from Fox St;
- The painting of the building, landscaping of the site, and any required alterations to the building;
- · Electricity and gas charges;
- Payment of an annual rental to the Council in the region of \$50 to \$100.
