I am writing concerning the issue of the NO DOGS ALLOWED signs in the South Wairarapa Camp grounds not only at Ngawi, but all the camp grounds.

I am a responsible rate payer & registered dog owner, who gladly pays fees every year.

My family and I have been camping at Ngawi for many years on our free weekends and now feel we are not welcome as we always take our family pet with us.

My Husband & I went up North not long ago and found every town welcoming with a dog friendly area to camp, all these campgrounds were nearly full. (Signed: Dog Friendly Camping, dogs must be on a lead).

I think the SWDC region is only unwelcoming place we have come across and this needs to be addressed.

SWDC are missing out on potential tourists to our beautiful region with their family pet. (Who may spend money in our region).

After talking with Murray Buchanan a few weeks ago, it has only left me feeling more frustrated as his solution is to park by the lighthouse, which is not an option as it is too hard and dangerous to get a 9metre bus with a boat on the back, around Kupaes Sail narrow single lane road.

Murray also said we could park on the roadside anywhere (Its Legal and we cannot be fined). But we are not allowed dogs in any Council reserve.

We love the township of Ngawi as we have friends and family out here but they have limited room or are hill side, so no room for parking.

I don't think the residents of Ngawi would be happy with a 9metre bus plus boat parked in front of their home obscuring their sea view and encroaching on their privacy, considering there is a camp ground across the road.

My elderly parents also camp with us in their campervan with their small dog and need to be close to council facilities.

I do realise there are a few bad dog owners (Penalise or fine them), but there are a lot of responsible dog owners, like me who feel like we have been penalised.

I would appreciate a full plan of the council land & area of Ngawi of where we are allowed to park with our little dog and if you could please help me come up with a practical solution to this issue.

### **Targeted rates proposal**

I am writing to voice my opposition to the idea of targeted rates to fund the shortfall that Council finds it faces for the Waihenga Centre. While we have some well-heeled folk in the district, I think asking poor families to fund a rates increase is nothing short of criminal.

Firstly, let me say that I am not opposed to the Waihenga Centre Project. I think Martinborough needs the Centre not only for its own community but as a world-class concert venue. We have had the NZ Symphony Orchestra come to Martinborough twice now to perform at Palliser Estate. The Barrel Room there provides excellent acoustics, so does the Town Hall. Just think of the national and international artists we could attract to world-class venue.

#### **World Class Venue**

The town hall has the potential to become Martinborough's "Opera House". Every great city in the world has an Opera House. We may not be a large city but we are a great little town.

We already produce some of the finest Pinot Noir in the world. We have the prestige to be able to host international performing artists. The small scale of the venue would mean limited tickets that could be sold at a premium price.

See: http://www.snapemaltings.co.uk/ for an example of how an old disused building became a great cultural centre. Martinborough is already a centre of great cuisine, wine and beer. Let's add the performing arts to the mix.

#### A reply to Max Stevens

Max, sadly, not everyone in our district is as well-heeled as I suspect you and Liz are. I myself have struggled and am very grateful for the rates rebate that I am able to claim.

The point is: there are a lot of people in Martinborough who simply cannot afford a rates increase. They are struggling to put food on the table for their families. I know this because I do confidential surveys for Statistics New Zealand. I get to take a very privileged look inside

the lives of New Zealanders. I cannot disclose any details but, believe me, there are families who would struggle even more if their rates (or rent) were to increase.

Since Martinborough now attracts so many visitors who spend money in the district and therefore pay GST, which is collected by IRD, my proposal is that Central Government should come to the party and make up the shortfall.

#### **Summary**

Of course we should have the Waihenga Centre. Used in the right way it will become a national (and even international) asset, not just one for the people of South Wairarapa. A national asset deserves some national funding. Let's ask central government to look at this and make a grant towards the building and hence further support the (performing) arts.

Dear Adrienne

Thank you so much for your time on Tuesday, it was great to catch up.

I really appreciated the discussion on the Country Music Festival and I was delighted to be able to tell you that Tauherenikau is picking up on your thoughts on opening up a Motorhome park and we are working with Bronwyn on this as we speak.

As mentioned Clareville was unable to host the Country Music Festival this year due to a resourcing issue however they are making noises that they wish to resume next year. I have the backing of the organisers "Kidnappers Country" from Hawkes Bay for a three year period and now that we have this opportunity, I do not want to see South Wairarapa and Tauherenikau give it up so it is imperative that the event is a great success. This could become a major event on the Wairarapa calendar.

I mentioned to you my push to secure a headline act and I have won through and we will have the Warratahs as the main band and the final act of the night.

This has cost an additional \$5,000 plus GST as noted in our attached budget but we believe as do key organisations such as Destination Wairarapa that this was a must in getting more people along and talking the festival to a new level.

The event has not made money before we understand, so this is a gamble for us to take on this additional debt but we believe with better management of costs and a better overall Saturday night we will get more along and therefore get the books on the right side of the ledger.

To assist us with this could I ask that the South Wairarapa District Council look to see if funds can be made available to cover the \$5,000 plus or inclusive of GST for the Warratahs. I am sure the Council will as we do want to see the Festival remain at Tauherenikau and this funding would be so appreciated to help us achieve that goal.

We are expecting up to 200 (number achieved last year and budgeted figure, however we are hoping for more) Motorhomes from around the country and we know that Wellingtonians enjoy coming to Tauherenikau and we will be targeting these two areas specifically to ensure good attendance numbers. Tranzit has come on board to assist us getting people from over the hill which has not been done previously.

We appreciate your support of Tauherenikau and we look forward to your reply.
