APPLICATIONS FOR GRANT FUNDING

Purpose of Report

To present an application for funding from Huri Huri and the Chamber of Commerce.

Recommendations

Officers recommend that the Council:

- 1. Receive the Application for Grant Funding Report.
- 2. Receive and consider the application for funding from the Wairarapa Chamber of Commerce for \$2,000 to help with the costs associated with hosting Wairarapa Business Awards.
- *3.* Receive and consider the application for funding from Huri Huri for \$2,000 to help with the costs associated with promoting the Wairarapa Summer of Cycling Campaign.
- 4. Either approve grant funding at the requested levels, or at partially funded levels, or decline funding.

1. Executive Summary

Funding applications have been received from Huri Huri and the Chamber of Commerce (see Appendix 1).

Council are requested to consider the applications on their merit and contribution towards the well-being of the South Wairarapa community and either grant funding, partial funding, or to decline funding.

2. Discussion

Every year as part of the annual plan or long term plan (LTP) process Council considers applications for funding at the time that submissions to the plans are considered. Historically all funding put aside for the purpose of grants is allocated; no discretionary funding is available for applications received during the year. Councillors elected to put aside a contingency in the Long Term Plan 18/28 so funding was available should midterm applications with merit be received.

2.1 Financial Implications

For the 18/19 year Council elected to hold a contingency of \$18,142 for funding applications received outside of the LTP submissions process.

Budget, allocations and contingency as at 8 August 2018 are shown below.

Allocating funding at the requested levels will leave a contingency of \$14,142.

Residential eligibility:

• Organisations, Charitable Trusts & Incorporated Societies must currently operate within South Wairarapa or have a broader Wairarapa-wide benefit.

Application forms:

- Will be accepted either in electronic or hard copy form.
- A separate application must be made for each project or event.

Annual grant:

- All applications are considered by the South Wairarapa District Council and awarded at their discretion and on the merits of each project for the greater wellbeing of the South Wairarapa community.
- There is no maximum amount for any one grant, however, the SWDC's resources are limited and funding support is not guaranteed on an on-going basis.
- Applicants will need to re-apply each year for consideration of funding to continue.
- There is a 12-month time limit for uplifting the funds from the date of notification of approval.
- After 12 months, if funds have not been uplifted the grant will be rescinded and a new application must be completed and submitted for consideration.
- Unused funds must be returned to SWDC.

Supporting material:

- Organisations are required to provide copies of their most recent annual report and financial statements that have either been audited or reviewed by a suitably qualified person.
- Within two months of completion of the project or event, applicants are required to send to the SWDC a completed Grant Accountability form.

Payments:

Nominations

The competition is open to receive nominations from the public and entry is through the completion of a nomination form. This will be promoted through local media and distributed through the Chamber newsletter, Facebook and website (www.wairarapachamber.co.nz).

Judging

The selection of 12 finalists will take place by a panel of judges overseen by an independent convenor – so everyone gets a fair go.

Initially, at least 24 businesses will be selected and presented to the judging panel. To help with this process, an independent researcher will write up 300 words on each business using the same format to ensure fairness. Twelve finalists will be selected via a rating system.

The 12 finalists will then be informed that they have been nominated and have reached the final stage. They will be invited to attend the awards night (which involves purchasing a table of ten). At this stage they will have the opportunity to decline if they don't wish to proceed any further.

The winners will again be selected via a rating system. This time via email, so that even the panel are kept unaware who the winners are until the actual awards night. This helps to maintain suspense and excitement.

Additional Awards

In addition to the four categories, there will be an overall *Supreme Award* and a *Tribute* to a well-known Wairarapa business icon.


