MĀORI STANDING COMMITTEE NOMINATION

Purpose of Report

To seek approval for a change to the Maori Standing Committee (MSC) Terms of Reference (TOR), to ratify a change of membership on the Committee and seek approval to appoint new members.

Recommendations

Officers recommend that the Council:

- 1. Receive the Māori Standing Committee Nomination Report.
- 2. Ratify the Hau Ariki Marae Committee recommendation to appoint Nathan Maynard to represent Hau Ariki Marae on Council's Māori Standing Committee.
- 3. Agree that the Maori Standing Committee Membership as defined by the Council and Committees Policy is updated to include two members from Featherston's "Pae tu Mokai o Tauira" Incorporated Society.
- 4. Agree that section 4 'Membership' of the Maori Standing Committee Terms of Reference is updated to include two representatives from Pae tu Mokai o Tauira.
- 5. To ratify Featherston's "Pae tu Mokai o Tauira" Incorporated Society recommendation to appoint Karen Mikaera and Narida Hooper to represent Pae tu Mokai o Tauira on Council's Māori Standing Committee.

1. Executive Summary

On the 27 March 1996 the Council Working Party and Tangata Whenua established a South Wairarapa District Council MSC. The Committee first met on the 17 April 1996 and was formally established following the adoption of the 1996/1997 Annual Plan on the 20 June 1996.

Membership of the Committee is as per by the Council and Committees Policy and is mirrored in the MSC TOR and currently is as follows:

- Two representatives from each of the three South Wairarapa marae
- One representative from each of the two Wairarapa Iwi

- Mayor ex-officio
- Two councillors appointed by the Mayor

Nominations must be received in writing from each participating body and membership is ratified by Council.

The MSC have been working with the Featherston Māori community to establish a voice around the table for Featherston Māori. As there is no marae in the Featherston area Pae tu Mokai o Tauira" - Incorporated Society has been formed to act as the governing body in lieu of a marae. Approval is sought from Council to amend the membership section of the Council and Committee's Policy and to appoint members from Pae tu Mokai o Tauira to the MSC.

2. Hau Ariki Nomination

At the Māori Standing Committee meeting of the 18 June 2018 John Shaw handed in his Hau Ariki Marae appointment resignation to the Māori Standing Committee and advised that a replacement would be appointed.

On the 2 July 2018 correspondence was received from Kevin Haunui, on behalf of the Hau Ariki Marae Committee, appointing Nathan Maynard as their representative (Appendix 1).

As per the Council and Committees Policy, a nomination has been received in writing and now Council are requested to ratify the change of nomination.

3. Pae tu Mokai o Tauira Nomination

Pae tu Mokai have held an inaugural meeting, appointed office holders, and formed an incorporated society.

On the 31 July 2018 correspondence was received from Narida Hooper, on behalf of Pae tu Mokai o Tauira, appointing Karen Mikaera and herself as Pae tu Mokai o Tauira representatives on the MSC. This nomination can only be ratified pending ratification of recommendation three.

Evidence of incorporation and correspondence is attached as Appendix 2.

4. Māori Standing Committee Terms of Reference

The MSC TOR is currently under a wider review and Council officers will work with representatives of the MSC to prepare an amended TOR. It is expected the TOR will be reviewed by the Audit and Risky Working Party and then be formally presented to Council for formal adoption.

5. Financial Considerations

There will be an unbudgeted financial impact should the policy change be adopted and new members appointed. The increase is relatively minor, and could be recovered in the next financial year, however for transparency it is presented below.

5.1 Increase in membership

The expected cost increase per year to allow two Featherston members is as follows:
