# **PROPOSED RENAMING OF RIMUTUKA HILL**

#### **Purpose of Report**

To inform Councillors of the process, for making a change to the current name of Rimutuka Hill.

#### Recommendation

Officers recommend that the Council:

- 1. Receive the information.
- 2. Consider whether to support a proposed name change of the Rimutaka Hill Summit to the Remutaka Pass.

## 1. Summary

The "Remutuka Pass Coordinating Group" has written to Council seeking support for their proposal to rename Rimutuka Hill as Remutuka Pass. The renaming would apply to the point of the 555m summit and the group believes the road name would then be consequential to this (i.e. it would change to Remutuka Pass Road). It is understood however that the name of the road (State Highway No 2 Rimutuka Hill) remains as at present unless the New Zealand Transport Agency (NZTA) subsequently decides to rename it (assuming the summit is renamed).

Such a name change (for the summit) must be submitted to the New Zealand Geographical Board (NZGB) for official adoption. The Board is charged to assess such applications taking into account the history of the place (both Maori and European). Issues such as the correctness of the name (spelling) are also considered.

# 2. Process

Applications to name, or change the name, of places in New Zealand can be made to the NZGB which is part of Land Information New Zealand. The Board describes its role as to:

- give places official names
- approve names that already exist unofficially
- change names (e.g. if spelling is different)

- remove names
- review names for Crown protected areas (e.g. national parks).

The Board sets out an extensive list of pre-consideration requirements which applicants to the Board must meet;

"NZGB Act 2008 S.15(2)

A proposal must— (a) be in the form provided for the purpose by the Board; and (b) meet the requirements specified by the Board; and (c) include the evidence necessary to support the proposal.

The Board has set out the matters to be covered to satisfy S15(2) (b) and (c) which would apply to the Rimutuka proposals, as follows ;

• A map or chart (preferably from Land Information New Zealand) showing the location and if applicable, the marked up extent of the proposed name.

• For historical names, sufficient information/evidence must be provided about the events, stories and people associated with the place (i.e. history/origin/meaning).

• For descriptive names, sufficient information/evidence must be provided to support the way in which the name describes the feature, unless it is obvious from other information provided

• For dual or alternative names, sufficient information/evidence associated with both names must be provided.

• For all proposals, evidence of the orthography must be provided (e.g. macrons for Māori names, correct spelling for personal names).

• For all proposals, the type of feature being named must be specified. An appropriate generic geographic component for the name should be included, though for populated places and historic sites, the generic is not generally used. Generally the English generic element is preferred for natural features.

• Proposers must confirm that they have referred to the Board's Frameworks document and other relevant standards during the compilation of their proposal.

# 3. Timeline

In terms of a timeline, the Board holds scheduled meetings through the year. For a proposal to be considered it must satisfy the above requirements, but also be notified to the Board by set due dates.

In that regard the next meeting of the Board is scheduled to take place on the 29<sup>th</sup> of April 2015. For that meeting acceptance of proposals closes on March 6<sup>th</sup> 2015.

### 4. Decision process

The NZGB considers place name proposals following a set process to make sure that it takes into account the views of affected people and groups. The general process is:

- Once a proposal is received, and all of the supporting information required has been provided, the Secretariat of the Board validates and researches the proposal, and carries out any further consultation that might be needed.
- The Secretariat then provides a comprehensive report with recommendations on the proposal for the NZGB to consider at its next meeting.
- The NZGB considers the proposal and recommendations, weighing them against the <u>NZGB Act 2008</u> and its <u>naming rules and policies</u>.
- **If** the NZGB supports the proposal, it advertises the proposed name asking for submissions.
- Anyone, including the person who proposed the name, can make a submission objecting to or supporting the name within the timeframe advertised by the NZGB (which is never less than one month and can be up to three months, but may be longer).
- The Secretariat then provides another comprehensive report on any submissions received to the NZGB's next meeting.
- If there are no submissions or if the NZGB agrees with all of the objecting submissions, then it makes the final decision.
- If the NZGB does not agree with the submissions objecting to the name, then the <u>Minister for Land Information</u> makes the final decision.

# 5. Conclusion

Council has been asked to consider the proposals for changing the name of Rimutuka Hill. The decision making body is the NZGB. To name or change a name the Board follows the provisions of the NZGB act 2008, which includes public consultation. The Minister is the final decision maker should a name or change of name be opposed.

# Appendix 1 – Remutaka Pass Coordinating Group Proposal

On a number of occasions over the past 10 years it has been publicly advocated that a name for the route that is the southern entrance to Wairarapa, more fitting to its status than the existing "hill road" be adopted. Most recently this issue was revisited to support the stated objective of local body leaders to give the route a higher profile and to promote this iconic route as a scenic drive.

Voluntary agencies and private donors raised the funds necessary to complete the purchase of land so that the whole route is now in public ownership. This has contributed to the remarkable regeneration of native vegetation, particularly at the higher levels.

The summit is frequently included on weather forecasting sites together with other passes such as Lindis, Porters, Lewis and Arthurs so that severe weather conditions bring it regular publicity from both the Met Service and the Transport Authority, but singularly as "Hill". To promote it as an iconic feature would take advantage of the same format used by these passes, all gratis. The Concise Oxford Dictionary defines Pass as a 'narrow passage through mountains', even more apt to the Remutaka route than applies to one or two of the South Island passes.

In a letter to the Geographic Board in June 2007 the adoption of the name Rimutaka Pass was advocated. In reply it was advised along the lines of what appears on the Board's website: *"Anyone can make a proposal for a new name or to change an existing name. Guided by good naming practice, the Board considers name proposals on a case by case basis. To make informed decisions we encourage consultation with interested parties such as iwi, and local councils and communities. We also investigate and research name proposals to check for correct spelling and historical accuracy".* A significant statement in the Board's reply was that the correct spelling of Rimutaka is actually REMUTAKA, and went on to say the Board is aware of this misspelling and if a new submission proposal came before it for 'Rimutaka Pass', the Board may wish to consider correcting the spelling of it and all other associated features currently named 'Rimutaka' (e.g. the range, stream, hill)

Rangitane O Wairarapa and Kahungunu ki Wairarapa have both indicated their support of the proposal.

This message is to seek your support for this initiative and your willingness to be associated with the group's representations. The Geographic Board has only two meetings each year and the agenda items for the next meeting close on 6 March 2015. Accordingly it is requested that your response be received by 27 February 2015.



# Appendix 2 - Process for NZ Official Geographic Names



#### Information available to any person making a proposal includes:

- 1. a proposal form with accompanying guidance notes;
- 2. a fact sheet;
- 3. New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008;
- 4. naming guidelines;
- 5. this flow chart; and
- 6. Protocol for Māori Place Names.

### **Consultation:**

Any persons making proposals are encouraged to undertake their own consultation (e.g. with the local community or interest groups, Department of Conservation, local iwi, Territorial Authorities, etc).

Documentary evidence of any such consultation should accompany proposals for new/altered/discontinued/approved geographic feature names.

By undertaking consultation, more weight may be added to support the proposal, giving recognition to the appropriate administrative, cultural and heritage aspects, as well as any historical, geographical and/or scientific research undertaken.

Although consultation is not mandatory, it is considered by the Board to be an important step towards determining a new, or altering an existing, or discontinuing an existing, or approving a recorded, geographic feature name.

When a proposal is received, the Board observes a 'Protocol for Māori Place Names', whereby the Board directly seeks the views of tangata whenua Māori in respect to proposals within their rohe.

SUPREME COURT.-Before his Honor Mr. Justice Wakefield and a Special Jury. Campbell v. Fitzgerald. This was an action brought by Lieut. Colonel James Campbell, of Christchurch, Canterbury, against James Edward Fitzgerald Esq. Superintendent of the Province of Canterbury, for a libel. Damages laid at £5000. Mr. King appeared for the plaintiff. Mr. Hart for the defendant. It appears that the plaintiff, after holding the office of Crown Land Commissioner, at Canterbury, for some time, was appointed Registrar of Deeds, &c., at Lyttelton, in room of Mr. Bintan, that gentleman succeeding the plaintiff in the office of Crown Land Commissioner. This appointment of the plaintiffs, it appears, gave great dissatisfaction in the Province, so much so, that a resolution of the Provincial Council was passed, expressive of their disapproval of the ap. pointment. In forwarding this, the Superintendent accompanied it by a letter to his Excellency, dated 1st December, 1853, containing the libel complained of, which was as follows :-- "That the plaintiff Lieut.-Colonel Campbell is wholly unfit to be entrusted with any public office whatever." The case occupied the whole of Thursday and till 12 o'clock on Friday, and after much able argument by Counsel on both sides, and on his Honor shortly summing up, reducing the case to very narrow limits, the Jury retued for about twenty minutes, returning with a verdict for the plaintiff. Damages, £600 — Independent.

[This decision is the subject of much comment in the Canterbury papers.]

The Athenæum continues to be conducted with that spirit which we should like emulated in our own locality. On the 12th inst., the Rev. J. Buller delivered a lecture upon "Woman and her influence ;" and on the 19th, Mr. Knowles was to give a reading from Macaulay's History of England.

The "Independent" of the 14th contains an announcement from Mr. Foley that he will arrive in July, with Pablo Fanque and the Monkey Jack.

The same journal contains a long letter from Mr. Fox to his constituents, in explanation of his policy.

PASSAGE OF THE REMUTARA.-Most of our readers are aware, that for the last ten years a mountain range has been the barrier standing between Wellington and the plains of the interior of this Province; and the little inland traffic that has been maintained with Wellington has been conduced by means of pack bullocks and a bridle path; a mode of locomotion not at all conducive to the rapid advancement of the colony. This great inland load and main altery of the Province his been in progress for years and cost many thousands of pounds -it passes through alluvial valleys and locky defiles; it crosses rapid rivers, and ascends, with a most easy grade, and serpentine course, the Remutaka range of mountains, and terminates in the great valley of the Wairatapa-is now open for traffic by drays. Mr. Kempton was the first to pass over on last Tuesday, with his dray of six bullocks, and dray laden with a ton of goods, en route to the Small Farm Settlements This road is forty miles long, thirty-five miles of which is as good as a turnpike road in England. We trust the Provincial Government will now, without any delay, push the road through the Forty-mile Bush, and if there is yet a small patch of land in that bush unpurchased (which we believe to be the case), we carnestly hope our Superintendent, while at Auckland, will se-cure the services of Mr. McLean to effect its purchase, or otherwise great mischief will be the result; for we hear of settlers who are "determined," now the road is open through the difficult country, to push into the in terior in search of new lands, which they will occupy "purchased or not purchased." Should this be done, and Mr. Roy displays the same energy and talent on the road through the Forty-mile Bush that he has displayed on the Remutaka line the future of Wellington is safe --- Independent, June 14.
