NO RUBBISH DUMPING SIGNS ALONG FENCE LINE OF O'CONNOR'S BUSH, SOLDIERS MEMORIAL PARK

Purpose of Report

For Councillors to approve 'No Dumping Rubbish' signs along the fence line of O'Connor's Bush, Soldiers Memorial Park.

Recommendations

Officers recommend that the Council:

- 1. Receive the information.
- 2. Approve signs to be erected

1. Executive Summary

There is an on-going problem with garden waste being dumped into the fence line of O'Connor's Bush. The community group 'Friends of the Bush' and SWDC officers wish to erect signage to detour garden waste dumping within the Bush.

Clause 5.1.2.22 of the Soldiers Memorial Park Management Plan states that any signs that are not visitor signs, information about facilities and features, traffic signs or temporary signage regarding events need to be approved by Council.

2. Background

O'Connor's Bush covers a large area of the south-eastern half of Soldiers Memorial Park and is classified as historic reserve. The bush is significant as it is remnant of the original lowland forest that once covered the Wairarapa area. Trees within the bush area include totara, titoki and kanuka. Native bird life is also present. The bush area has been fenced, and steps are taken by the local community to control weeds and possums.

3. Discussion

3.1 Options

The problem of residents dumping garden waste in O'Connor's Bush has been on-going for some time and the problem is not improving. Community Groups including 'Friends of the Bush' are getting frustrated with this dumping.

The Soldiers Memorial Park Reserves Management Plan states that "the indigenous flora and fauna and natural environment shall as far as possible be preserved".

Garden waste dumping spreads weeds which threaten the ecosystem of the Bush. Signage stating that dumping is not allowed, along with location information for the transfer station may make residents think and act differently, rather than contaminating their reserve. There are two areas where signs will be attached to the fence itself, and one area where the sign will be attached to a wooden standard just out from the fence on the berm.

Two options of sign are provided.

Option one is a traditional 'no dumping' sign.

Option two is more directed and explanatory, in an attempt to put ownership of the future of the bush back on the residents.

4. Conclusion

Sign option two is more in keeping with the amenity values of Soldiers Memorial Park and the O'Connor's Bush area. Officers recommend that Council approves the erection of three of these signs as described above.
