Lyn Tankersley gave a brief update on the new Governments project and how it was going. Also has set up a database with all the captured info for the latest Governments Healthy Homes project listed. Covers illnesses, # of occupants, # of bedrooms, ages of family members and ethnicity.

Bob Frances pointed out that we are close to our 2000th house install. Lyn to look out for a family.

General Income homes. Insulation has never been cheaper in the whole 10 years of the project.

Lyn average cost for 100 square meters installed home not under the project.

100 sq meter Ceiling install Pink Batts R3.6 \$1400.00

100 sq meter underfloor Terra Lana Wool R 1.4 \$1662.00

Total installed price \$3062.00

The whole amount can be put onto your Wellington Regional Council Rates.

Tessa-Jane gave brief run down on her side of the current project. They still have .2 hours for Public Health Nurse in put into the programme but gathering info not now needed as well documented that the programme is benefiting our community in many ways.

They want to do something else that will benefit the Wairarapa Community.

Hutt Valley are doing over crowding in homes, looking at trees close to buildings, curtains, heating and checking that clients are enrolled with a medical practitioner. Targeting children, Maori and Pacific Islanders, and Rheumatic Fever. (Not a lot of cases in the Wairarapa and are well known)

Have been working locally in preschool centres. PHO has been working on Respiratory pathway.

Housing is on the agenda, air quality and heating. Liaising with other providers.

Tessa-Jane referals need to be linked in to this. Report back when she returns from Annual Leave.

Lyn Patterson is very interested in the housing as no research has been done into this locally. Emergency housing issues in Masterton.

Andrew Whitehead mentioned that there have been changes in Social Housing locally.

MSD will do all questions (Lyn has not got a clue what this refers to sorry)

Pathways locally have specific concerns around housing for their clients.

Lyn Patterson wants to look into Air Quality and where the worst areas are to do research on this.

Tim Bird concerned that there are no WINZ referrals coming through and will follow up with staff.

Andrew Whitehead attended ECA design workshop in Wellington. Phillipa Howden Chapman spoke on Heat- Fuel poverty, lack of wood and can't afford the power.

Bob Francis to follow up if funding still coming to us from DHB.

Chris Peterson to find out when Sue is doing (sorry guys I missed this to)

Lyn Tankersley to forward info from Hawkes Bay Regional Council who are doing the heat smart funding to help cut CO2 omissions into their local environment, to other committee members especially Lyn P.

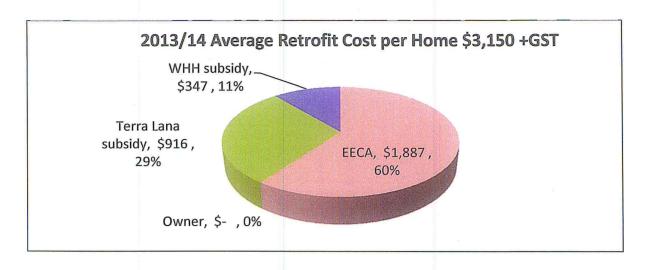

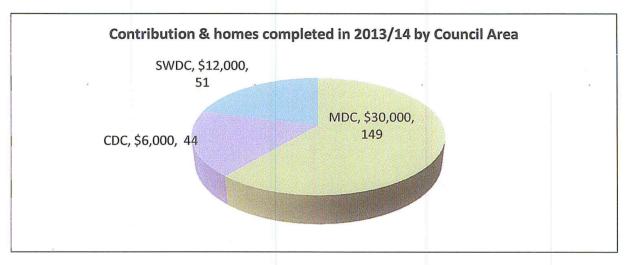

4.1. The Wairarapa Arts Festival Trust

The application met the criteria and partial funding was allocated. The Committee asked the Trust to ensure that the event was widely promoted.

4.2. Aaron Cross

The application met the criteria and funding was allocated for advertising, followed by full funding on the following conditions:

• That Kuranui College was contacted with a view that the course be promoted to interested students.

- That a public display, exhibition or presentation in a district library (or other venue) be organised to enable the community to see the created work.
- That 10 participants have enrolled in the course.

4.3. Greytown Early Years

The Greytown Early Years project was deemed to be low priority and was declined in favour of funding other projects with wider community benefits.

4.4. Janie Nott

The application met the criteria and funding was allocated on the condition that advertising was taken out in the Greytown Grapevine, Martinborough Star and Featherston Phoenix in preference to the Carterton Cryer (advertising in the Carterton Cryer is not required but may continue).

4.5. Greytown Arts Festival Committee

The application met the criteria and funding was allocated. The Committee asked that the art work created be made available for display during the Greytown Arts Festival weekend in a public space like Stella Bull Park before it is permanently placed on the Greytown Cycle Trail.

4.6. Wairarapa REAP

The application met the criteria and partial funding was granted.

4.7. St Teresa's School

The application met the criteria and partial funding was allocated in an equitable manner to all schools applying for a grant for the upcoming Wairarapa Kapa Haka Festival.

4.8. Featherston School

The application met the criteria and partial funding was allocated in an equitable manner to all schools applying for a grant for the upcoming Wairarapa Kapa Haka Festival.

4.9. Tuturumuri School
