Purpose of Report

1. Executive Summary

The Draft Annual Plan 2013/2014 was released for public consultation on the 19 May 2013. A total of 53 submissions (Appendix 1), have been received resulting in 111 individual requests or comments. The submissions have been summarised and are presented as Appendix 2. Officers have reviewed the submissions and made comments against individual requests.

APPLICATION TO ERECT ELECTION SIGN ON COUNCIL LAND AT OTAUIRA RESERVE, STATE HIGHWAY 2, FEATHERSTON

Purpose of Report

To obtain a decision on an application by Don Farr to erect Labour Party election signs on Council-owned land at Otauira Reserve, Featherston, for the upcoming Ikaroa Rawhiti by-election.

Recommendations

Officers recommend that the Council:

- 1. Receive the information, and.
- 2. Approve the temporary use of Otauira Reserve by all political parties to erect election signs during 2013 provided they comply with all other relevant standards in the Wairarapa Combined District Plan.

1. Background

Don Farr, of the New Zealand Labour Party, has applied to erect election signs for Ikaroa Rawhiti electorate on Otauira Reserve, Featherston in June 2013. The reserve is located on the Rimutaka side of Featherston near the entranceway to the township.

2. Discussion

2.1 Public Places Bylaw and the Wairarapa Combined District Plan

The use of signs in the South Wairarapa is regulated by the Public Places Bylaw and the Wairarapa Combined District Plan (District Plan).

Clause 211.1 of the Public Places Bylaw prohibits any projections on public places without the consent of Council. In addition to Council's agreement, election signs must comply with the following rules in the District Plan in order to avoid resource consent (set out in Rule 21.1.16(g)):

- (i) The total face area of all signs per site must not be greater than 5m².
- (ii) Any one sign must not exceed 3m².
- (iii) The maximum height of any sign is 6 metres.

(iv) Any temporary sign advertising a General Election shall not be displayed for more than 8 weeks before and shall be removed within 7 days after the date of the event.

(In this instance the by-election takes place on 29 June. The 7 days after rule covers all temporary signs, however election legislation requires signs be removed before the day of the election.)

- (vi) No sign shall be located on any public road or other public place.
- (vii) Signs must not be located in a position that would conceal the required sight distances from any access or intersection (Appendix 5; 6 metres from entrance).
- (viii) Signs must not conceal the visibility of an existing official sign or traffic-controlling device.
- (ix) No sign shall use reflective materials, or be illuminated, flashing or moving.
- (x) The following minimum letter/character height standards for signs in the 100km/hr speed zones shall be: main message 300mm, second message 150mm.

2.2 Otauira Reserve/State Highway 2

State Highway 2 is considered to be the only road suitable for displaying election signs. However, in respect of the western entrance to Featherston, there are no suitable locations within the road reserve due to the steep banks or wide shoulders that form part of the sealed road area.

Otauira Reserve would be a suitable alternative location. Council has the ability to agree to allow election signs on public land and any hoardings would need to be placed further back on the reserve. Officers have consulted Council's Roading and Reserves Manager, Ian Richards, who is not concerned with the placement of election signs on the site provided they are positioned behind the existing fence and at least 6 metres from the entranceway to the reserve (see standard vii).

With these measures in place the temporary use of the site would not adversely affect traffic safety or conceal required site distances.

2.3 How would the District Plan apply?

If Council approves the application then the following standards in the District Plan would be implicitly consented to:

- (i) total face areas of signs greater than 5m² (which would collectively allow other political parties to place hoardings on the site) and
- (iv) locating a sign on a public place.

All other standards would still apply and would act as triggers for resource consent.

3. Conclusion

Officers recommend that Council approves the use of Otauira Reserve for the temporary use of election signs by all political parties during 2013 elections. The reserve is the most suitable site in the South Wairarapa and is located at the Featherston town-threshold from the Wellington Region. Officers recommend that approval is extended to all political parties to ensure that Council is seen to be acting fairly and consistently.
