The meeting moved into public exclusion at 3:05pm.

Mr Crimp tabled and spoke to a report recommending the purchase of land suitable for waste water irrigation in Greytown.

#### **Discussion Points:**

- Councillors noted that the report recommendations triggered the Policy on Significance. Mr Crimp advised that as \$324,300 capital expenditure had been set aside for waste water land purchase in the 12/22 LTP for this financial year; further statutory requirements will need to be followed through.
- The purchase of irrigable land is ahead of the waste water project schedule and there is a risk that GWRC may push Council to accelerate the programme. Irrigation to land would remain a long term project and it was unaffordable to accelerate the entire schedule.
- District wide cost share, as per the solid waste disposal cost share arrangement, was discussed. Mr Crimp undertook to investigate cost share options and a decision would be made during the 2014/15 annual planning process.
- Flooding, interest rate calculations, the current grazing license, continued public access to gliding facilities, land and river for recreational purposes, and an extension to the Papawai Marae urupa were discussed.

## COUNCIL RESOLVED (DC2013/151):

- 1. To receive the information.
- 2. To approve purchase 118.3564ha more or less as described in Appendix A and enter into a purchase and sale agreement to affect this purchase.
- 3. To approve the drawing down a loan of up to \$3M to cover the purchase and attendant costs.

- 4. To approve non budgeted expenditure to cover the capital and operational costs associated with this purchase.
- 5. To enter into a licence to occupy with Jury Hill Gliding Club Inc.
- 6. To enter into a licence to occupy with James Allan Bicknell.
- 7. To enter into a grazing licence with Paul and Diana Capes.
- 8. To note that a desktop analysis of the land prepared by Lowe Environmental Impact indicates of the 118.3564Ha, 84.5 ha (following exclusion for buffer zones) is irrigable which will achieve 121% of the average year wastewater treatment flow (summary report attached as Appendix B).
- 9. To agree to a land swap of land included in this purchase with PT Papawai 13 WN 72/9 (approximately 8ha).
- 10. To acknowledge this transaction is significant in terms of Councils "Policy on Significance".
- 11. To acknowledge this purchase was not able to be flagged in either the 2012/22 LTP of 2013/14 LTP due to the timing this opportunity occurred.
- 12. To note this purchase is not an open market transaction and is based on a valuation report provided by Baker & Associates.
- 13. To note that disposal by irrigation to land is a permitted activity under the Wairarapa Combined District Plan.
- 14. To delegate to the Mayor and Chief Executive authority to execute the requisite documents.
