- Change **proximity to sensitive and/or Residential Sites. 1.** This should read No Brothel shall be located in or within 100 meters (in a straight line) from the site boundaries of any sensitive site.
- **Signage of Commercial Sexual Services. 3.** This should read The maximum area of total signage per site should be 0.5m².
