Councillors discussed the report with Mr Crimp and noted:

- That the recommendation was an 'up to' amount due to expert opinion that the vendor's price was higher than its value.
- Mr Crimp believed that with the projected increase of the Greytown population some of the land proposed for purchase would be required in the future; however there were many unknown variables and an absolute argument for purchase could not be made.
- That the Gliding Club impacted the above ground direct irrigable land by up
 to 1ha, however Mr Crimp was of the opinion that the Club would not impact
 the level of treated waste that could be applied to the land if other methods of
 disbursement were used.
- That the 4mm of wastewater able to be applied to the land, and pivot irrigator requirements under consent conditions, would prevent wastewater from being leached into waterways.
- That official land valuations had been obtained before previous land purchases.
- That the Gliding Club lease arrangements were \$2,500 per year and that after 10-years their lease would be based on lost baleage revenue. Mr Crimp did not believe there was a direct revenue loss as a result of Gliding Club operations.
- There was some councillor concern that the land was over and above what would be required in the foreseeable future.
- That the three waters reserve fund diverted depreciation funding accumulated at \$600k per year; \$300k of which was required for renewals.
- That there were sufficient funds in the three waters reserve fund to fund the land purchase.

1. To receive the report in regard to the purchase of land at Papawai.

To note the benefits of this purchase are to provide additional capacity for the distribution of treated wastewater (if necessary), to accommodate growth in Greytown, to maintain public access to the Waiohine and Ruamahanga Rivers, and to address potential reverse sensitivity issues at the proposed purchase site, and also the issues raised by neighbours at the southern end of the main block.
