Conduct of Business:

The meeting was held in the Council Chambers, 19 Kitchener Street, Martinborough

and was conducted in public between 9:00am and 11:03am.

Open Section

A1. Karakia

Mayor Napier opened with a reading from Socrates.

A2. Apologies

A3. Conflicts of Interest

There were no conflicts of interest declared.

A4. Public Participation

Robyn Ramsden requested Council repair the damage to the Featherston community caused by a vacant lot on Main Street since 2014. Ms Ramsden had made an alternate proposal to those suggested in the Council officer's report via email to Council. In the short term the space could be developed into a container mall or creative space if it was paved.

Jennifer Grey stated that Featherston Community Board minutes showed they were waiting to receive further material from Council before running another public meeting, not that the meeting was cancelled, and that the Featherston community still wanted a meeting. Ms Grey expressed disappointment that only half of the

Featherston Town Centre plan consulted on was implemented, and requested Council consider what Featherston needed and pursue development of facilities that matched the other South Wairarapa towns. Ms Grey requested Council read the tabled papers and hold the Chief Executive accountable.

Sue Fox alleged that Trusthouse pursued a land swap knowing that their land was unsuitable for development. Prior to the land swap, Council was receiving income from the land. Council now owned land that was restricted in usability and generated no income. Ms Fox requested Council use someone with relevant skills to develop a fully considered plan of all options and then provide recommendations of the best way forward to Council for consideration. Ms Fox suggested that in the short term the lot was grassed over, run as a carpark or that a container mall is developed.

A5. Actions from Public Participation

Mayor Napier clarified that Ms Ramsden's proposal was for Council to build a new building to house a library, Council staff and commercial tenants.

B1. Featherston Town Centre

Mr Crimp advised that the third paragraph under the executive summary was incorrectly included in the Council report and that he had been advised that the meeting referred to in paragraph 3.3 had been cancelled.

Councillors discussed Chorus' statement of position on the easement, the timeframe and links with the spatial plan project, tabled documents and suggestions from the public, and a desire for further consultation with the Featherston Community Board.

Impacts and potential adoption delays of the Greater Wellington Regional Council's draft Natural Resources Plan on the primary Featherston Wastewater Treatment Project (FWWTP) consent application and hearing were also discussed.
