B Decision Papers

B1. Adoption of 2014/2015 Annual Report

Mayor Staples welcomed Phil Kennerley to the meeting.

Mr Crimp explained that asset revaluation was mainly due to a more cost efficient roading contract, the asset replacement cost was deemed to be lower and so the asset value went down. Asset revaluation only occurs once contracts across the country and forecast trends have been reviewed. Mr Crimp explained variances with operating income, employee entitlements, service performance levels for fire hydrants and the Ministry of Health water subsidy.

Mr Kennerley reported that among other items reviewed, Audit NZ had investigated asset revaluation and the increase of debt against budget and financial benchmarks and were now in a position to issue a clean audit opinion.

DISCLAIMER

Audit NZ reviewed the annual general charge calculation every year and Audit NZ was confident that Council was complying.

Councillors agreed that if Martinborough Rugby Club wanted further concessions then they needed to apply for registration as a campground.

- 4. That the Martinborough Rugby Club works with Council's Amenities Manager to identify a designated area as close as possible to the entrance in order to limit damage to grassed areas.
