## **Open Section**

Cr West read the Council affirmation.

### A1. **Apologies**

There were no apologies.

#### A2. **Conflicts of Interest**

There were no conflicts of interest.

#### A3. **Public Participation**

Mr Woodgyer spoke against the sale of Old Stella Bull Park. He was concerned about increased traffic down Cotter Street, selling land in Greytown when more recreational space was needed and selling land without a clear title. Mr Woodgyer requested that reserve contributions from the development were ringfenced for Greytown and that all costs associated with bringing the land to market be made public.

Mr Gray disputed that the intent of past councils to sell Old Stella Bull Park was clear and unambiguous. Mr Gray had participated in the community workshops and meetings relating to the potential sale of land. Mr Gray suggested that a

diagram should have been supplied with the report, that the land was of some significance to Greytown and that Greytown had a requirement for more recreation space.

Mrs Geisler was not in favour of Council being asked to make significant decisions under urgency and queried why the land wasn't sold previously and where the 2016 discussion was documented. Mrs Geisler believed there was ambiguity and queried whether the intention of one Council was valid 17 years later. Mrs Geisler believed there were financial considerations that needed to be explained and further options presented in the Council report.

# A7. Actions from Public Participation

Matters raised under public participation were deferred to agenda item B1 Council Disposal of 'Old Stella Bull Park'.

# **B** Decision Reports from Chief Executive and Staff

# B1. Council Disposal of 'Old Stella Bull Park' Report

For the avoidance of doubt officers were seeking a resolution for the sale of Old Stella Bull Park. Councillors agreed that the intent of previous councils was to sell Old Stella Bull Park, however due to a large delay in enacting the resolution to sell from 2001, it was agreed to remove the words 'has always been clear and unambiguous' from the second recommendation.

It was established that Council had entered into a sale and purchase agreement with a developer in good faith. It would be remiss to pull out, regardless of current community views, due to reputational risk and significant financial risk should the purchaser sue for damages.

The total contributions from the subdivision was expected to be \$1.2m - \$1.5m, members discussed this being ringfenced for Greytown. Members discussed putting policies and procedures in place to ensure this could not happen again, and releasing public excluded documents relating to Old Stella Bull Park.
