Tried to get council to help with enforcement but to no avail. It appears that Council has no interest or provision to deal with these situations outside of the 'holiday' season. Request that a Ranger has a coastal presence from Labour Weekend through Queens Birthday Weekend, and that someone can respond to concerns outside of the scheduled times.</p>	<p>Note that Council has advertised for a casual Bylaw Officer to cover the coastal camping areas during peak periods, including Labour Weekend and Easter.</p>

The most obvious place for policies and rules governing its use would be in the CRMP if the lease agreement is ready in time. Suggest we add a section in the RMP about the Sandy Bay lease area in the Specific Reserves section, and possibly re-name the "Specific Reserves" section to "Specific Reserves and Recreation Areas" to more accurately describe the contents if Sandy Bay is included. If the lease information is not ready, then include in the CRMP a reference to the likelihood that Sandy Bay will be a Council managed launching site.</p>	<p>Note that any development or maintenance at Sandy Bay is dependent upon the finalised lease agreement.</p> <p>If the lease is signed in time for the CRMP to be finalised, agree to include a section in the CRMP describing Sandy Bay as a council managed recreation area, but make it clear that it is managed by its lease agreement.</p> <p>If the lease does not eventuate by the time the CRMP is approved then information about Sandy Bay will not be included in the CRMP.</p>

The general objectives and policies from section 4 be shifted to part of the Vision and Primary Objectives in chapter 1 so it is clear that all reserves (specific and bundled) are guided by the general policies. 2. The plan should identify indigenous biodiversity values in coastal areas and provide direction on how these values should be managed. In particular, a section on biodiversity values be included in site descriptions for all specific reserves (see Appendix I of the submission). 3. That suggested amendments are incorporated into the final plan. Many of the reserves contain rare or sensitive habitats and intersect with areas identified by GWRC as Biodiversity Management Areas. 4. 				<p>The boardwalk would not then be required. Sec 3.5 Mangatoetoe - Support this section. Sec 3.6 Surf Breaks - Priority to upgrade the toilet at the main surf break N of Ngawi with a composting toilet. Consider sec 3.6.3(1) is unreasonable and unrealistic - camping should be allowed on these reserves as surfers stay overnight anyway and that was the impetus for installing the current toilet. Sec 3.7 Ngawi Utility Reserves - Concerned that "natural processes will be left to run their course" and note that these reserves, easements and drains must be proactively managed. Sec 3.8 Whatarangi - Submit that policy 3.8.3(3) is not reasonable as the reserve site already encroaches on the road. Suggest Council proactively maintains and consolidates the coastline to give effect to the Vision and Objective of the plan. Suggest the Whatarangi subdivision intersection sightlines be improved. Policy 06 Signage - Request better coordination between Council, DOC and NZTA in regard to coastal signage, particularly speed limits and road safety. Random and out-dated signs should be improved/maintained/rationalised. Policy 12 Camping - Submit that freedom camping should be allowed on any Council reserve. Policy 13 Refuse & Waste Disposal - Council must provide refuse disposal options as well as recommending visitors pack their rubbish out, otherwise the burden to clean up is placed upon residents. Toilet and refuse facilities must be increased and maintained to reflect increase in visitors. Policy 14 Fire Management - Does not support fire pits or that fires are generally permitted.
