DECISION ON THE PAPERS

This is the first Temporary Authority for this applicant. An application for a new Off Licence must be made within 3 months of the granting of this Temporary Authority.

The application was sent to the Police and Inspector and no reports of opposition were received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard, as set out in s.3, s.4 and s.136 of the Act. A further condition is imposed that the licensee must comply with s.59 and regulations 14 and 15 of the Sale and Supply of Alcohol Regulations 2013.

We grant the Temporary Authority for a three month period from the issue date, and authorise the issue of an authority.


The present conditions on licence number **044/OFF/189/2009** shall continue to apply.
