5.4 Proposed Toilet at Ngawi Surf Break

The Roading and Reserves Manager tabled and spoke to the report on the proposed toilet replacement at Ngawi. Mr Rimene asked that council officers discuss proposals with potential to impact historical or cultural Maori sites with iwi directly rather than from an archaeologist as in this case.
