### 4.2 Iwi Representatives for Water Race Users Group

Council's Assets Manager discussed the waste water treatment plant consent requirement to create a liaison group, to include iwi representation, and for the group to consult with Council on planned waste water actions. Rangitane already had a large number of committee commitments and Mr Rimene suggested that the Maori Standing Committee may be better placed to recommend a representative for Rangitane endorsement. Members of the Maori Standing Committee were also more familiar with the water ways in the South Wairarapa.

The Commission were tasked to ascertain from Maori how iwi should be represented within any new governance structure. At a previous meeting there was a strong

interest expressed in forming a partnership with any newly formed Council to equally share control of natural resources such as Lake Wairarapa and the regional forests.

The Wairarapa councils were working with the Commission to find a good governance fit for the Wairarapa and SWDC were lobbying for more local influence for Wairarapa environmental decisions.

Having a Maori seat on Council was discussed as an alternative option by the Committee.

A public forum was planned for the end of May 2016.

Mr Tipoki closed with a karakia.
