DECISION

This is an application HT3 Partnership for a renewal off-licence in respect of premises situated at 45-53 Omarere Road, Martinborough, known as Haythornthwaite Wines.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises.

CONDITIONS

Cellar Door

- 1) Alcohol may be sold only on the following days and during the following hours:

 Monday to Sunday 10.00 am to 10.00 pm
- No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
 - a) on the premises; or
 - b) from grapes or fruit harvested from land on which the premises are situated.
- 4) Drinking water is to be freely available to customers while alcohol is being supplied as a free sample.
- 5) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display:
 - a) At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
 - b) A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
 - c) At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

Remote Sales

- 6) A remote sale of alcohol may be made at any time on any day.
- 7) The holder of this licence must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
- 8) No alcohol is to be delivered from the premises on Good Friday, or Christmas Day, or before 1.00 pm on Anzac Day.
- 9) No alcohol is to be delivered from the premises at any time on Easter Sunday unless it is grape wine or fruit or vegetable wine made
 - a) On the premises; or
 - b) From produce harvested from land on which the premises are situated.



- 10) Condition 9 applies whether the alcohol is delivered by the seller or by some other person
- 11) The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- 12) The licensee complies with condition 11 if they comply with regulation 14 of the Sale and Supply of Alcohol Regulations 2013 to be a reasonable procedure for that purpose.
- 13) The holder of an off-licence who sells alcohol by remote sale must comply with regulation 15 of the Sale and Supply of Alcohol Regulations 2013 requiring information to be provided by remote sellers.

REASON FOR DECISION:

On reading the Inspector's Report and recommendations the DLC has no reason to believe the applicant is not suitable to renew their Off Licence and accordingly the renewal is granted subject to the applicant updating the website for Remote Sales to comply with regulation 14 of the Sale & Supply of Alcohol Act 2013, in accordance with Section 64.

OFF-LICENCE



Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 HT3 Partnership is authorised to sell or deliver alcohol on or from the premises situated at 45-53 Omarere Road, Martinborough, and known as Haythornthwaite Wines, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS OF LICENCE

Cellar Door

- Alcohol may be sold only on the following days and during the following hours: Monday to Sunday 10.00 am to 10.00 pm
- No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day. 2)
- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made a) on the premises; or
 - b) from grapes or fruit harvested from land on which the premises are situated.
- Drinking water is to be freely available to customers while alcohol is being supplied as a free sample.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed 5) and must display:
 - At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted. a)
 - A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read b) by all people entering at each principal entrance.
 - At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated c) persons.

Remote Sales

- 11) The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- 12) The licensee complies with condition 11 if they comply with regulation 14 of the Sale and Supply of Alcohol Regulations 2013 to be a reasonable procedure for that purpose.
- 13) The holder of an off-licence who sells alcohol by remote sale must comply with regulation 15 of the Sale and Supply of Alcohol Regulation 2013 requiring information to be provided by remote sellers.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

(a) Until the close of the period of 3 years commencing with the date of its issue; or

(b) If an application for the renewal of the licence is duly made, until the application is determined; or (c)

If the licence is renewed, until the close of the period for which it is renewed.
