#### **DECISION**

This is an application Pirinoa Country Store Limited for a renewal off-licence in respect of premises situated at 2774 Lake Ferry Road, Martinborough, known as Pirinoa Country Store.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises.

#### REASON FOR DECISION:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Medical Officer of Health, who do not oppose the issue of the licence. In addition no objections have been raised. The application also meets the criteria set out in the Local Alcohol Plan. The District Licensing Chair acting pursuant to s.127 of the Act therefore accordingly grants an application by Pirinoa Country Store for a renewal Off Licence subject to the following conditions.

# CONDITIONS

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1:00 pm on Anzac Day.
- (b) Alcohol may only be sold or delivered on the following days and during the following hours: Monday to Sunday between 8.00 am to 8.00 pm.
- (c) Drinking water must be freely available and displayed whenever alcohol is being supplied by way of complimentary tastings.
- The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - A restriction of sale or supply of alcohol to persons under the age of 18 years of age.
  - Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (e) The whole of the premises is designated as an 'undesignated' area.
- A copy of the licence and all conditions subject to which it is issued, must be attached to the inside of the premises so to be easily read by all people entering at each principal entrance.
- (g) The holder of a manager's certificate or a properly notified manager shall be on duty and on the premises at all times alcohol is sold.
- (h) A Host Responsibility Policy must be maintained and displayed at all points of sale and the Licensee must ensure all staff receive training in their policy.

## **OFF-LICENCE**

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Pirinoa Country Store Limited** is authorised to sell or deliver alcohol on or from the premises situated at **2774 Lake Ferry Road, Martinborough**, and known as **Pirinoa Country Store Limited**, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

#### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

(a) Until the close of the period of 3 years commencing with the date of its issue; or

(b) If an application for the renewal of the licence is duly made, until the application is determined; long

(c) If the licence is renewed, until the close of the period for which it is renewed.
