

of an application by Wharekauhau Country Estate Limited for a renewal offlicence pursuant to s.127 of the Act in respect of premises situated at 4132 Western Lake Road, Featherston known as Wharekauhau Country Estate.

DECISION

This is an application «licensee» for a renewal off-licence in respect of premises situated at 4132 Western Lake Road, Featherston, known as Wharekauhau Country Estate.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of alcohol for consumption off the premises.

CONDITIONS OF LICENCE

The following conditions are consistent with the style of off-licence sought:

- 1. Alcohol may be sold only on the following days and during the following hours: Monday to Sunday 7.00 am to 10.00 pm.
- 2. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
- 3. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - a. on the premises; or
 - b. from grapes or fruit harvested from land on which the premises are situated.
- 4. Drinking water is to be freely available to customers while alcohol is being supplied free as a sample.
- The licensee must display:
 - a. At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
 - b. A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
 - c. At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
- 6. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Wharekauhau Country Estate Limited** is authorised to sell or deliver alcohol on or from the premises situated at **4132 Western Lake Road, Featherston**, and known as **Wharekauhau Country Estate**, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS OF LICENCE

The following conditions are consistent with the style of off-licence sought:

- 1. Alcohol may be sold only on the following days and during the following hours:

 Monday to Sunday 7.00 am to 10.00 pm.
- 2. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
- 3. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - a. on the premises; or
 - b. from grapes or fruit harvested from land on which the premises are situated.
- 4. Drinking water is to be freely available to customers while alcohol is being supplied free as a sample.
- 5. The licensee must display:
 - a. At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.

The conditions sought are consistent with the style of an off-licence.

THE LICENSED PREMISES

The premises, situated at 4132 Western Lake Road, Featherston are more precisely identified as outlined in a plan date stamped as received by the South Wairarapa District Licensing Committee on the 17 October 2017.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **4132 Western Lake Road, Featherston** is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 3 years commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
