Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Terroir Wines Limited** is authorised to sell or deliver alcohol on or from the premises situated at **672 Dry River Road**, **RD 1**, **Martinborough**, and known as "**Terroir Wines Limited**", to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises. The remote sales endorsement is pursuant to s.40 of the Act and applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

Principal Business:

The principal business is a small boutique winery with remote sales only of wine produced at the vineyard.

- 3. No alcohol is to be delivered from the premises on Good Friday, or Christmas Day, or before 1.00 pm on Anzac Day.
- 4. No alcohol is to be delivered from the premises at any time on Easter Sunday unless it is grape wine or fruit or vegetable wine made
 - (i) On the premises; or
 - (ii) From produce harvested from land on which the premises are situated.
- 5. The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.

The conditions sought are consistent with the style of off-licence sought.

THE LICENSED PREMISES

The premises, situated at 672 Dry River Road, RD 1, Martinborough are more precisely identified as outlined in a plan date stamped as received by the South Wairarapa District Licensing Committee on the 14th May 2015.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **672 Dry River Road**, **RD 1**, **Martinborough**, is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -
