#### **DECISION**

This is an application by 57-63 New York Street, Martinborough for an off-licence in respect of premises situated 57-63 New York Street, Martinborough known as Reid Brothers Distilling

The application is in respect of premises in which the principal business is that of remote sales only.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, I deal with the matter on the papers.

I am satisfied as to the matters to which I must have regard as set out in s.105 of the Act and I grant the applicant an off-licence pursuant to s.17.

#### REASON FOR DECISION

I have considered this application on the basis of the report received from the Licensing Inspector who does not oppose the issue of the Licence. In addition no objections have been raised. The District Licensing Chair acting pursuant to s. 99 of the Act therefore accordingly grants the Off- Licence subject to the following Conditions:

## CONDITIONS OF LICENCE

ENDORSEMENT: Section 40 of the Sale and Supply of Alcohol Act 2012 applies to this licence. The licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

- (a) Alcohol may be sold from the premises at any time on any day, and be delivered somewhere else for consumption off the premises;
- (b) No alcohol is to be delivered from the premises on Good Friday, Easter Sunday, Christmas Day or before 1 pm on Anzac Day.
- (c) No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11 pm on any day and before 6 am on the next day.
- (d) The licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor;
- (e) A certified manager must be appointed to the business, however, that manager does not need to be on duty when alcohol is sold remotely;

- (g) The licensee must ensure that on their website and catalogue they display;
  - The licence holder's name and licence number:
  - The date on which the licence expires.
- (h) The licensee must ensure that printed on every receipt issued for alcohol sold remotely
  - The licence holder's name and licence number;
  - The date on which the licence expires.
