DECISION

This is an application by **7 Mahupuku Street, Greytown** for an off-licence in respect of premises situated **7 Mahupuku Street, Greytown** known as **Alexia Limited**

The application is in respect of premises in which the principal business is that of remote sales only.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, I deal with the matter on the papers.

I am satisfied as to the matters to which I must have regard as set out in s.105 of the Act and I grant the applicant an off-licence pursuant to s.17.

REASON FOR DECISION

I have considered this application on the basis of the reports received from the Alcohol Licensing Inspector and the reporting agencies who do not oppose the issue of the licence. In addition the District Licensing Committee has not received any objections from members of the public.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.99 of the Act, therefore accordingly grants Alexia Limited the new OF Licence, subject to the following conditions (a) - (f).

CONDITIONS OF LICENCE

Remote Sales

- (a) A remote sale of alcohol may be made at any time on any day
- (b) No alcohol is to be delivered from the premises on Good Friday, or Christmas Day or before 1:00 pm on ANZAC Day.
- (c) No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made:
 - on the premises; or
 - from grapes or fruit harvested from land on which the premises are situated.
- (d) The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day or before 6:00 am on the next day. Whether the alcohol is delivered by the seller or by some other person.
- (e) The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is deliver is a minor.
- (f) The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;

- i. The licence holder's name and licence number;
- ii. The date on which the licence expires;
- iii. A legible image of the licence or a clearly identified link to such an image.

THE LICENSED PREMISES

The premises, situated at **7 Mahupuku Street**, **Greytown**, are more precisely identified as outlined in a plan date received by the **South Wairarapa District Licensing Committee**

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **7 Mahupuku Street, Greytown**, is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
