- If an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of three years after the period for which it is renewed.



The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with with subpart 7 of part 2 of the Act.

RECOMMENDED CONDITIONS OF LICENCE

No variation to the conditions of licence 44/ON/006/2014 have been requested.

- 1. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day to any person who is not on the premises to dine
- Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 7:00am to 1:00am the following day.

- 3. The whole of the premise is undesignated.
- Drinking water is to be freely available to customers for consumption while the premises are open for business at the following places: drinking water to be provided on tables.
- 5. Food must be available at all times at reasonable prices and within a reasonable time of being ordered.
- The licensee must ensure that there is available at all times for sale and consumption, at reasonable prices, a range of non alcoholic refreshments and low alcohol beverages.
 - The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of liquor.
- 7. The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons

The following additional condition is recommended

- Conditions prescribing steps to be taken by the licensee to ensure that the provisions of this Act relating to the management of the premises concerned are observed:
 - The Host Responsibility Policy must be displayed in view of the public
 - Signs must be prominently displayed detailing information regarding alternative forms of transport

DECISION

This is an application by SLOW BURNER LTD for renewal of an on licence in respect of premises situated at 128 Main Street, Greytown, known as "Cuckoo Cafe".

The application was publicly notified in the Wairarapa Times Age on the 21st May 2015. The public notice had a small error in that it was advertised in the name of lan Preston not the not the correct applicant's name Slow Burner Limited. This omission was neither wilful nor misleading, therefore we waive the omission for the minor error in the public notice pursuant to Section 208 of the Act.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matters on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 9 May 2018, that being three years from the first anniversary of the licences and authorise the issue of notice of renewal.

The following additional condition is recommended

The renewal with variation will be for three years from the anniversary of the first licence and a replacement licence is to be issued.
