DECISION

This is an application by Cowen Davis Limited for an on-licence in respect of premises situated at 6 Kitchener Street, Martinborough, known as Martinborough Wine Centre.

The general nature of the business to be undertaken is that of a Bottle Store.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of liquor for consumption on the premises, to any person who is present on the premises.


The applicant's attention is drawn to ss.56, 57 and 214 (3) of the Act obliging the holder of an on-licence to display:-

- At each principal entrance to the premsies a sign attached to the inside or outside of the premises, so as to be easily read by people immediately outside the entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>
- A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND
- A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

THE LICENSED PREMISES

The premises, situated at **6 Kitchener Street, Martinborough** are more precisely identified in a plan date stamped as received by the South Wairarapa District Licensing Committee on **22 August 2014**.

OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Cowen Davis Ltd** is authorised to sell or deliver alcohol on or from the premises situated at **6 Kitchener Street**, **Martinborough**, and known as **Martinborough Wine Centre**, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1:00pm on Anzac Day; and
- (b) Liquor may be sold or delivered only on the following days and during the following hours: 9:00am to 9:00pm
- (c) The premises is undesignated
- (d) Drinking water is to be freely available to customers while alcohol is being supplied.
- (e) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

THE LICENSED PREMISES

The premises, situated at 6 Kitchener Street, Martinborough, are more precisely identified as outlined in a plan date stamped as received by the South Wairarapa District Licensing Committee on 19 August 2014

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 6 Kitchener Street, Martinborough is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue, or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
