#### **DECISION**

This is an application by **Snappy Dragon Limited** for an on-licence in respect of premises situated at **8 Kitchener Street**, **Martinborough**, known as **'Ingredient'**.

The general nature of the business to be undertaken is that of a Café.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an onlicence authorising the sale and supply of liquor for consumption on the premises, to any person who is present on the premises, subject to the following conditions:

- No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day to any person who is not present on the premises to dine
- 2. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 10.00am to 10.00pm

- 3. Drinking water is to be freely available to customers at all times while the premises are open for business.
- 4. Food must be available for consumption on the premises as follows: At all times when the premises are authorised to be open for the sale of alcohol, a range of food choices must be readily available. Menus must be visible and food should be actively promoted.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale of liquor, a reasonable range of non-alcoholic refreshments and low-alcohol beverages
- 6. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons

The conditions sought are consistent with the style of On licence.

The applicant's attention is drawn to ss.56, 57 and 214 (3) of the Act obliging the holder of an on-licence to display:-

- At each principal entrance to the premsies a sign attached to the inside or outside of the premises, so as to be easily read by people immediately outside the entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; <u>AND</u>
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

Sections 14 to 16 and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 (The Act), **Snappy Dragon Limited** is authorised to sell and supply liquor on the premises situated at **8 Kitchener Street**, **Martinborough** and known as **'Ingredients'**, to any person for consumption on the premises and to let people consume alcohol there.
