**DECISION** 

This is an application by Oh My Goodness Limited for a renewal on-licence in respect of premises situated at 1/8 Kitchener Street, Martinborough known as "Oh My Goodness"

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal onlicence authorising the sale and supply of liquor for consumption on the premises, to any person who is present on the premises.

The licence may issue with the following conditions:

- a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day to any person who is not present on the premises to dine
- b) Alcohol may be sold only on the following days and during the following hours:

  Monday to Sunday 8.00 am to 12.00 midnight
- c) Drinking water is to be freely available to customers at all times while the premises are open for business.
- d) Food must be available for consumption on the premises as follows: At all times when the premises are authorised to be open for the sale of alcohol, a range of food choices must be readily available. Menus must be visible and food should be actively promoted.
- e) The licensee must have available for consumption on the premises, at all times when the premises are open for the sale of alcohol, a reasonable range of non-alcoholic refreshments and low-alcohol beverages
- f) A properly appointed certified manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their name must be prominently displayed.
- g) Information, advice and assistance about alternative transport options must be freely given to guests on the licensed premise.
- h) The responsible consumption of alcohol is to be promoted at all times by instigating and maintaining the steps outlined in the application for the licence and displaying the host responsibility policy at all times.
- i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- j) The licensee must display:
  - At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
  - b. A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.

At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
