DECISION

This is an application by **Hygge Limited** for an on-licence in respect of premises situated at **139 Todds Road, Martinborough**, known as "**StoneCutter Vineyard**"

The general nature of the business to be undertaken is that of a winery.

REASONS FOR THE DECISON

The application was duly advertised and no objection or notice of desire to be heard has been received. Neither the Police not the Medical Officer of Health raises any matters in opposition.

- 8. The responsible consumption of alcohol is to be promoted at all times by instigating and maintaining the steps outlined in the application for the licence and displaying the host responsibility policy at all times.
