Sections 14 to 16 and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 (The Act), Hamilton Davis Limited is authorised to sell and supply liquor on the premises situated at 1-3 Memorial Square, Martinborough and known as "The Wine Bank", to any person for consumption on the premises and to let people consume alcohol there.

The general nature of the business conducted under the licence is a tasting room with casual dining.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with with subpart 7 of part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold only on the following days and during the following hours: Monday to Sunday 8.00 am to 11.00 pm
- 2. No alcohol is to be sold or supplied on Good Friday, Easter Sunday or Christmas Day, or before 1.00 pm on Anzac Day.
- 3. The premises is designated 'supervised'.
- Drinking water is to be freely available at all times when the premises is open for the sale, supply and consumption of alcohol.
- At all times when the premises are open for selling, supplying or consumption of alcohol, there must be a reasonable range of non-alcoholic beverages and low-alcohol drinks available for purchase at reasonable prices.
- Food must be available for consumption at all times the premises are open for the sale, supply and consumption of alcohol. The range must be in accordance with the menu submitted with this application or of a similar range and standard. Food must be actively promoted and available within a reasonable time of ordering.
- 7. A properly appointed certified manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol and their name must be prominently displayed.
- Information, advice and assistance about alternative transport options must be freely given to quests on the licensed premises.
- The responsible consumption of alcohol is to be promoted at all times by instigating and maintaining the steps outlined in the application for the licence and displaying the host responsibility policy at all times.
- 10. The licensee must display:
 - a. At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
 - A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
 - At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

The conditions sought are consistent with the style of a tavern-style on-licence.

THE LICENSED PREMISES

The premises, situated at 1-3 Memorial Square, Martinborough, are more precisely identified as outlined in a plan received by the South Wairarapa District Licensing Committee on 10th October 2019.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 1-3 Memorial Square, Martinborough is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provision of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Either -
 - Until the close of the period for which it was last renewed; or i.
 - If it has never been renewed, until the close of the period of 12 months after the day it was issued; but ii.
- (b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either -RAPA DISTRICA
- Until the close of the period of 3 years after the period for which it was last renewed; or

If it has never been renewed, until the close of the period of 4 years after the day it was issued.

DECISION

This is an application **Hamilton Davis Limited** for a renewal off-licence in respect of premises situated at **1-3 Memorial Square, Martinborough**, known as **The Wine Bank**.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises.

CONDITIONS

It is recommended that the licence be issued subject to following conditions:

(a) Alcohol may be sold on, or delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours

Monday to Sunday 8:00 am to 10:00 pm

- (b) No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1:00 pm on ANZAC Day.
- (c) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made:
 - on the premises; or
 - from grapes or fruit harvested from land on which the premises are situated.
- (d) Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which the sampling occurs.
- (e) A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display:

- At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
- A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
- At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

Remote Sales

- (g) A remote sale of alcohol may be made at any time on any day
- (h) No alcohol is to be delivered from the premises on Good Friday, or Christmas Day or before 1:00 pm on ANZAC Day.
- (i) No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made:
 - on the premises; or
 - from grapes or fruit harvested from land on which the premises are situated.
- (j) The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day or before 6:00 am on the next day. Whether the alcohol is delivered by the seller or by some other person.
- (k) The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is deliver is a minor.
- (I) The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;
 - i. The licence holder's name and licence number;
 - ii. The date on which the licence expires;
 - iii. A legible image of the licence or a clearly identified link to such an image.

REASON FOR DECISION:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Medical Officer of Health, who do not oppose the issue of the licence.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.127 of the Act, therefore accordingly grants Hamilton Davis Limited the OF Licence renewal for The Wine Bank, subject to the above Conditions (a) - (l).
