DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. Executive Summary:

Tuhirangi Rugby Football Club Incorporated seeks a special licence to sell and supply alcohol at the Kokomai Creative Festival Comedy Night.

No opposition or concerns have been reported by the reporting agencies.

The club has had similar special licences in previous years without any concern.

Section 142 of the Sale and Supply of Alcohol Act 2012 sets out the criteria that the Inspector must enquire into and report on, and in turn the District Licensing Committee must consider when determining this application.

STATUTORY CRITERIA

The special licence is for a limited time and within the club rooms. The club has held special licences in previous years without any matters of concern.

There is no reason to believe that the amenity and good order of the locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of the licence.

Whether the applicant has appropriate systems, staff and training

Scott Macdonald, Wayne Jephson, and Carmen Harrison have been identified as the duty mangers. They are all holders of manager's certificates.

No designation has been requested.

Provision of food, non-alcoholic and low-alcoholic drinks & transport assistance:

An all-night BBQ will be providing food items such as sausages, steak, meat patties and paua fritters. A range of low and non-alcoholic beverages will be provided including, coke, lemonade, juice, and ginger beer. Free water and low alcohol beer including Speights Mid and Amstel Light will be available at the bar. A bus service and a van has been arranged to provide transport.
