DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for *Inspiring Women* to be held at **38 Donald Street, Featherston** and known as *Tarureka Estate*, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified. Accordingly I deal with the matter on the papers.

I am satisfied as to the matters to which I must have regard as set out in s. 3, s. 4 and s.142 and of the Act. I grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, I set the following conditions under s147 on the licence:

Conditions

- Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: 15 September 2016 5.30 pm to 10.00 pm
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- The licensee must have available for consumption on the premises, at all times when the
 premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic
 and low-alcohol beverages.
- 6. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
