THE APPLICATION

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Madcaps Performance to be held at Hau Ariki Marae, 131 Regent Street, Martinborugh and known as Hau Ariki Marae, where alcohol will be consumed on the premises.

Up to 126 people are expected to attend each night, entry is by ticket sales. Hau Ariki Marae has given written consent for the event to be held on the premises.

Food, low and non-alcoholic drinks will be available at the event.

The following days and hours are being sought for the event;

Wednesday 28 September 2016 - 6.00 pm to 11.30 pm Thursday 29 September 2016 - 6.00 pm to 11.30 pm Friday 30 September 2016 - 6.00 pm to 11.30 pm Saturday 1 October 2016 - 6.00 pm to 11.30 pm

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

Accordingly I deal with the matter on the papers.

THE REASONS FOR THE DECISION

The applicant has provided host responsibility details which demonstrate that suitable measures will be undertaken with regard to responsible sale or supply of acohol and that harm will be minimised. A certified manager will be on duty at all times.

Both food and low and non-alcoholic drinks will be available throught the performances. The performances are of low risk and of limited duration.

I am satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 of the Act.



DECISION

I grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, I set the following conditions under s147 on the licence:

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

> Wednesday 28 September 2016 - 6.00 pm to 11.30 pm Thursday 29 September 2016 - 6.00 pm to 11.30 pm Friday 30 September 2016 - 6.00 pm to 11.30 pm Saturday 1 October 2016 - 6.00 pm to 11.30 pm

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. Alcohol may be sold or supplied only to the following types of people: ticket holders
- 8. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 9. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested
