DECISION DETERMINED ON THE PAPERS

THE APPLICATION

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Fundraiser Movie Night** to be held at **48 Kemptons Line, Greytown** and known as **Elm Grove,** where alcohol will be consumed on the premises.

The following days and hours are being sought for the event: Friday 14 October 2016,7.00pm to 12 midnight.

The event is a movie night in a woolshed to raise funds for an early childhood centre.

Substantive food options and low and non-alcoholic drinks will be available throughout the evening.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

Accordingly I deal with the matter on the papers.

THE REASONS FOR THE DECISION

The applicant has provided details which demonstrate that suitable measures will be undertaken with regard to responsible sale or supply of alcohol and that harm will be minimised.

Both food and low and non-alcoholic drinks will be available throughout the event. The event is of low risk and of limited duration.

Safe transport options have been put in place for the event by the applicant.

I am satisfied as to the matters to which I must have regard as set out in s. 3, s. 4 and s.142 of the Act.



DECISION

I grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, I set the following conditions under s147 on the licence:

Conditions

This licence is subject to the following conditions:

- 1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
 - a. Friday 14 October 2016, 7.00 pm to 12 midnight.
- 2. The licensed area is designated as restricted.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol.
- 5. A reasonable range of food must be available for consumption on the premises at all times during licenced hours and must include non-snack food.
- 6. A reasonable range of non-alcoholic and low-alcohol beverages must be available for consumption on the premises at all times during licenced hours.
- 7. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 8. Alcohol may be sold or supplied only to the following types of people: ticket holders
- 9. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - a. Intoxicated persons are not to be served or supplied alcohol
