   November 2016, 7.30 pm to 11.30 pm.
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must display signage as follows:
  - At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. Alcohol may be sold or supplied only to the following types of people: invited guests
- 8. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
  - (i) Intoxicated persons and minors are not to be served or supplied alcohol
  - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested

### **DECISION DETERMINED ON THE PAPERS**

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for *Quiz Night* to be held at 23 Viles Road, Feathertson and known as Feathertson Golf Club, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, we set the following conditions under s147 on the licence:

#### **Conditions**

This licence is subject to the following conditions:

- 1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: Friday 25 November 2016, 7.30 pm to 11.30 pm.
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must display signage as follows:
  - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. Alcohol may be sold or supplied only to the following types of people: invited guests
- 8. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
  - (i) Intoxicated persons and minors are not to be served or supplied alcohol
  - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested

Dear Licensee,

While processing your recent special licence application for a sporting quiz night (SP1312) I noted several concerns that I would like to bring to your attention.

The first concern is that of submitting special licence applications according to the required statutory timelines. Section 137 of the Sale and Supply of Alcohol Act 2012 requires special licence applications to be lodged at least 20 working days before the event occurs. This means that there must be 20 working days in between the day on which the application is accepted by Council and that on which the event occurs.

The Featherston Golf Club has recently submitted several special licence applications that have not met this requirement. Licences SP1302 and SP1280 did not meet this requirement. Please ensure that all future applications are lodged so that there are 20 complete working days from the date of lodgement until the day of the event. Future applications that don't meet this requirement will be rejected.

The Inspector has also noticed the price of alcohol provided in your most recent application. This beverage list has light beer priced more expensively than full-alcohol beers such as Tui, DB and Lion. The Inspector considers that this fails reasonable host responsibility requirements. Non-alcoholic beverages should be priced as the cheapest beverages available. Low-alcohol options should be priced more expensively and full-alcohol options should be the dearest beverages you offer. After this framework has been followed, you are free to decide the appropriate cost of beverages. That is, host responsibility practices should always come before business/financial choices. The Inspector recommends that your pricing should be reviewed in regards to this information.
