This licence is subject to the following conditions:

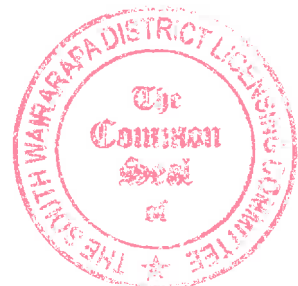
1. Alcohol may be supplied for consumption on the premises only on the following day and hours:

4. The licensee must have the licence available and produce it on request.
5. Alcohol may only be supplied to those people attending the event.
6. The licensee must ensure compliance with the provisions of the Act regarding supply to prohibited persons:
 - a. Intoxicated persons and minors are not to be supplied alcohol.

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **80th Birthday Celebration** to be held at **Stella Bull Park, Main Street Greytown** and known as **Stella Bull Park**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, we set the following conditions under s147 on the licence:

1. Alcohol may be supplied for consumption on the premises only on the following day and hours:
 - a. **Saturday 24 December 2016**
 - b. **10.00 am to 2.00 pm.**
2. Drinking water is to be freely accessible to those persons attending the event.

4. The licensee must have the licence available and produce it on request.
