DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Ravecourse 2020 to be held at 1496 State Highway 2, Featherston and known as Tauherenikau Racecourse, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Medical Officer of Health who do not oppose the issue of the licence.

The South Wairarapa District Council Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants the Special Licence to 121 Underground for Rave 2020 at Tauhereinikau Racecourse, subject to the following Conditions 1 - 14.
