DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Lions Club Over 70s Christmas Luncheon to be held at 62 Bell Street, Featherston and known as Kiwi Hall, 62 Bell Street, Featherston, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Medical Officer of Health, who do not oppose the issue of the licence.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants the Special Licence to the Lions Club of Featherston Incorporated, subject to the following Conditions 1 -8.

Accordingly, we set the following conditions under s147 on the licence:

Conditions

1. Alcohol may be supplied for consumption on the premises only on the following days and

Sunday 24 November 2019 - 12:00pm to 2:00pm

2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

- 3. The licensed area of the premises is to be designated as: undesignated
- 4. A certificated manager must be on duty at all times when the premises are open for the supply and consumption of alcohol.
- 5. Food must be available for consumption on the premises at all times the premises are open for the supply and consumption of alcohol.
- 6. The licensee must have available for consumption on the premises, at all times when the premises are open for the supply and consumption of alcohol, a reasonable range of non-alcoholic beverages.
- 7. The Licensee must display signage as follows:
